Pursuant to Sections 11-13-508 and 509 of the Utah Code the Seven County Infrastructure Coalition presented a tentative budget to the Board in its November public meeting and called a public hearing and provides notice thereof for the next year's budget.

NOTICE IS FURTHER GIVEN that the Coalition Governing Board calls a public hearing for the purpose of inviting public comment on the proposed 2026 Budget and the economic impact the budget will have on the private sector. The public hearing will be held on December 11, 2025, at 10:00 a.m., or as soon thereafter as feasible, at the regular meeting place of the Coalition at the Carbon County Commission Chambers located at 751 East 100 North, Price, Utah 84501. The meeting will also be available electronically. The Governing Board directs the budget officer to cause notice of the public hearing to be published (1) one time in a newspaper of general circulation in one of its member counties at least seven days prior to the date of public hearing, and (2) on the Utah Public Notice Website at least seven days prior to the date of the public hearing. The Coalition has no taxing powers and accordingly no tax increase is or can be made in connection with the 2026 budget.

NOTE: The proposed 2026 Budget will be posted on the Utah Public Notice Website for any wishing to review it prior to the December 11th meeting.

Resolution No. 2025-12A

RESOLUTION ADOPTING THE 2026 FINAL BUDGET AND RELATED MATTERS.

WHEREAS, pursuant to Section 11-13-512 of the Utah Code, after a public hearing on the tentative budget, the Coalition is required to adopt a final budget for the following fiscal year; and

WHEREAS, the Coalition Board considered a tentative budget for 2026 on November 13, 2025, and called a public hearing for December 11, 2025; and

WHEREAS, as required by its rules and regulations and by Section 11-13-509 of the Utah Code, a notice of public hearing was posted on the Utah Public Notice Website and published in a newspaper of general circulation in the Coalition at least seven days prior to today; and

WHEREAS, the Executive Director has prepared a final budget for consideration and adoption for the Coalition Board which has been presented on this date:

NOW, THEREFORE, be it resolved by the Governing Board of the Seven County Infrastructure Coalition, Utah as follows:

1. On this date, the Governing Board held a public hearing on the 2026 tentative budget and heard all comments from the public and has reviewed the 2026 final budget and with the modifications expressed in public meeting finds that such budget is in tabular form presenting actual revenues and expenditures for the last completed fiscal year, estimated total revenues and expenditures for the current fiscal year; and the budget officer's estimates of revenues and expenditures for the budget year 2026 with an estimate of the amount of revenue available to serve the needs of each fund, the portion to be derived from sources other than general property taxes, which is all revenues, and the portion that shall be derived from general property taxes, which is none, and an estimate of expenditures together with specific work programs.
2. In accordance with the above findings, the Governing Board hereby adopts the 2026 final budget.
3. All parts of this Resolution are severable, and if any section, clause or provision of this Resolution shall, for any reason, be held to be invalid or unenforceable, the invalidity or unenforceability of any such section, clause or provision shall not affect the remaining sections, clauses or provisions of this Resolution.

4. All resolutions or parts thereof in conflict herewith are, to the extent of such conflict, hereby repealed and this Resolution shall be in full force and effect immediately upon its approval and adoption
