# **2026 General Session Process - *DRAFT***

# Policy Review Committee role - *DRAFT*

- Meets weekly and creates a bill tracker on behavioral health legislation.
- Bill positions:
  - **Priority Support:** Priority for passage
  - **Support:** Support the bill
  - **Support In Concept:** Support but there is an area of concern
  - **NEW - Request Revisions:** Request revisions to the bill (requires position statement outlining the requested revisions)
  - **For discussion** - Consider use of the **Oppose** position
  - **No Position:** Neutral
  - **Hold:** Hold the bill for further information

# Communications with Commission - *DRAFT*

- Staff will send the weekly bill tracker to commissioners.
- The Policy Review Committee will invite commissioners to attend all weekly meetings.
  - Commissioners may comment on bills as members of the public during weekly meetings.
  - Commissioners may communicate input on bills via email to staff.
- The Policy Review Committee members are representatives of the Behavioral Health Commission in their interactions with the Legislature.

# Commission role - *DRAFT*

- Legislators can present legislation to Commission at 1/15/2026 meeting.
- Staff will email commissioners to flag any bills that:
  - The Policy Review Committee deems as high priority; or
  - Explicitly impact the Commission.
- Commission conducts two - three votes (voting by email as needed) to vote on priority legislation.
  - Maximum of ten bills.
  - **Will the Commission oppose any legislation?**
- Commissioners testify on legislation directly related to Commission's strategic plan or annual priorities.
- Staff may communicate with legislators on behalf of the Commission.

# Key dates

- **Thursday, January 15:** Commission meeting
  - Legislators present bills to discuss with commissioners
- **Tuesday, January 20:** First day of session
- **Thursday, February 5:** Conduct e-vote on priority bills
  - Staff will circulate potential bills for vote on Thursday, January 29
- **Thursday, February 18:** Commission meeting
  - Conduct second vote on priority bills
- **Friday, March 6:** Last day of session

# Decision points

- Determine whether to **change or remove** any of the original ten recommendations, including:
  - Reduce State Hospital request to 30 beds.
  - Reduce receiving center request to one receiving center.
  - Reduce requested funding for peer recovery support services.
- Determine whether to **add** any recommendations requested by legislators:
  - Increase Medicaid collaborative care rates.
  - Funding for SafeUT National Guard.
- Specific bills could be reviewed through the process described earlier.
