Nate Wilberg, Dixie MPO introduced Thomas McMurtry to present information on how various Utah cities have implemented Transportation Utility Fees to help maintain public roadways.

e. Review of MPO bylaws regarding the election of Chair/Vice Chair

g. Request to expand scope of Sheep Bridge Trail Project under current funding.

Leslie Fonger-Washington County is requesting the scope of work from partial design to full design of the Sheep Bridge Trail Project. Leslie said it was discovered that they could complete the full design process with current funds.
