Long Range Planner Elizabeth Fewkes presented that on January 3, 2023, Eagle Mountain City amended Chapter 9 of the General Plan to include State-required Moderate Income Housing strategies. An error in Strategy 5 omitted the word "other," which the State requested be corrected to match Utah Code 10-9a-403(2)(b)(iii)(W). This amendment updates Strategy 5 to reflect the exact Code language while maintaining compliance with State requirements.

Planner Steven Lehmitz, along with Jason Thompson from AWA Engineering, discussed the proposed Master Development Plan and Rezone request for the Spring Run Plaza project at SR-73 and Spring Run Parkway. The proposal covers a 27.35-acre parcel, with the first 8.15 acres to be rezoned to Commercial Community and subdivided into six lots, while the remainder would stay Commercial until a future amendment. Since the February 18, 2025 meeting, the applicants have worked with staff, elected officials, and neighbors to determine the width and alignment of Road A, which will function as a minor arterial, with a portion constructed as part of this phase.

The Council had remanded the item to the Planning Commission on October 21, 2025, directing updates to Table 6.10.080 on permitted animal numbers for larger lots, adding Council notification requirements for alternative animal management decisions, and allowing animal-housing structures to be located closer to property lines with an approved plan.

Long Range Planner Elizabeth Fewkes explained that the proposed ordinance updates Chapter 9 of the General Plan to correct an omission in Moderate Income Housing (MIH) Strategy 5. The word "other" was inadvertently left out when the City adopted State-required MIH strategies on January 3, 2023. During the 2025 MIH report review, the State identified the error and requested the correction to ensure the strategy matches the exact wording in Utah Code 10-9a-403(2)(b)(iii)(W) and avoid misinterpretation. The City's report remained compliant because the intent of the law had been met.

Community Development Director Brandon Larsen presented an updated Annexation Policy Plan. The plan identifies six areas of unincorporated Utah County that Eagle Mountain City may consider for future annexation. It includes an annexation policy map and criteria to guide City decision-makers in evaluating annexation proposals. Staff ensured the document meets all requirements of Utah Code \$10-2-803 and highlights key considerations such as water availability, neighborhood compatibility, and statutory limitations.

Each of the six annexation areas includes a description of associated benefits and challenges. The proposal was presented to affected entities at the November 12, 2025 Planning Commission meeting and to the City Council on November 18, 2025. Councilmembers were generally supportive and suggested adding key desirable or undesirable land uses for each area.

City Attorney Marcus Draper reported that on November 4, 2025, voters considered a ballot proposition to enact a Recreation, Arts, and Parks (RAP) Tax. State law allows a city council to impose the tax if a majority of voters approve it. After canvassing the election results on November 18, 2025, the Council confirmed the majority of voters supported the RAP Tax. To formally implement the tax, the Council must adopt an ordinance, which was presented for consideration.
