

**MAYFIELD TOWN
ORDINANCE NO. 2025-6**

**AN ORDINANCE OF MAYFIELD TOWN, SANPETE COUNTY, UTAH, ADOPTING
PROPOSITION #10 AS APPROVED BY THE VOTERS AT THE NOVEMBER 2025
GENERAL ELECTION AUTHORIZING THE CONTINUATION OF THE RECREATION,
ARTS, AND PARKS (RAP) SALES AND USE TAX.**

WHEREAS, on November 4, 2025, the voters of Mayfield Town approved Proposition #10, which authorized the continuation of a local sales and use tax of one-tenth of one percent (0.1%) for the purpose of funding recreation, arts, parks, and cultural facilities and programs; and

WHEREAS, Proposition #10 was submitted to the voters in accordance with Utah Code § 59-12-1402, which permits municipalities to impose a sales and use tax for zoological, arts, botanical, recreational, and cultural purposes upon voter approval; and

WHEREAS, the Town Council desires to formally adopt Proposition #10 as approved by the majority of the qualified electors of Mayfield Town at the November 2025 General Election;

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF MAYFIELD TOWN,
UTAH, AS FOLLOWS:**

Section 1. Adoption of Proposition #10.

Mayfield Town hereby adopts and enacts Proposition #10, as approved by a majority vote at the November 2025 General Election, authorizing the continuation of the local Recreation, Arts, and Parks (RAP) sales and use tax of one-tenth of one percent (0.1%) on taxable transactions within the Town.

Section 2. Use of Tax Revenue.

Revenues collected from the RAP tax shall be used exclusively for recreational, arts, parks, cultural, and botanical facilities and programs within Mayfield Town or in accordance with applicable interlocal agreements.

Section 3. Effective Date of Tax.

The reauthorized RAP tax shall take effect on the date determined by the Utah State Tax Commission in accordance with Utah Code § 59-12-1402, following the proper filing and certification procedures.


Section 4. Severability.

If any section, provision, or part of this Ordinance shall be held invalid or unconstitutional, such invalidity shall not affect any other portion of this Ordinance, which shall be given effect without the invalid provision.

Section 5. Effective Date of Ordinance.

This Ordinance shall become effective immediately upon posting and publication as required by law.
