He noted that the Main Street Improvement grants total \$410,000. The trail project bid came in at \$1,559,679 from Sunroc. With adjustments and available revenue of \$2,239,000, and approval from UDOT to proceed with the connector trail in the spring, the project is expected to remain under budget.


Council Member Paul Madsen inquired whether the additional funding needed to address flood-related issues along the trail was part of the original bid. Monte explained that additional funding was available and a change order has been carried out to complete the necessary culvert work.

He also discussed ongoing safety concerns related to children climbing on the train engine. Although railings have been installed near the steps, children continue to climb on the equipment. Plans are underway to install "No Trespassing" signage to deter further unsafe activity.
