Zoning Administrator/DRC Report – Kenny Funk:

- A. DRC: Kenny F
 - **Shannon Boundary Adjustment:** This request has several issues including no frontage.
 - Boundary Adjustment: An adjustment was presented for a subdivision on Highway
 38.
 - Billboards: A request has been made for a billboard, but the code is very vague.

DISCUSSION ITEMS:

A. Discharge of Firearm Ordinance: Laurie H presented a draft Ordinance regarding shooting within city limits. In this draft she referenced Utah state code. There had been discussion about allowing the discharge of firearms in agricultural zones, however it appears this would not work in the A-5A zone. Bob K mentioned that the presented ordinance addresses hunting, but not recreational shooting. There was further discussion about distance away from residents' homes. David H suggested removing the section that only addresses hunting. Kenny F suggested stating what is required for those shooting on property that is not owned by them.

- **B. Billboards:** The code for billboards is very vague. Kelli S volunteered to research other city's codes to see what they have on record.
- C. Fence Ordinance & Permit It was decided to table this item until next month.
