TAYLORSVILLE, UTAH **ORDINANCE NO. 25-16**

AN ORDINANCE OF THE CITY OF TAYLORSVILLE ESTABLISHING THE 2026 TAYLORSVILLE CITY COUNCIL MEETING SCHEDULE.

WHEREAS, the Taylorsville City Council (the "Council") met during its regularly scheduled meeting on December 17, 2025, to consider, among other things, establishing the 2026 Taylorsville City Council Meeting Schedule; and

WHEREAS, UTAH CODE ANN. § 10-3-502(1) requires that the council of each municipality shall by ordinance prescribe the time and place for holding its regular meeting(s) and hold a regular meeting at least once each month; and

WHEREAS, UTAH CODE ANN. § 52-4-202(2) further requires a public body which holds regular meetings which are scheduled in advance over the course of a year to give public notice at least once each year of its annual meeting schedule; and

WHEREAS, TAYLORSVILLE MUNICIPAL CODE § 2.12.040(A) requires that the council prescribe by ordinance the time and place of its regular meeting schedule and the City Recorder shall give public notice at least once each year of the annual meeting schedule of the City Council; and

WHEREAS, the Council has deemed it appropriate to establish an annual meeting schedule for 2026 for meetings of the City Council and other City Boards, Commissions, and Committees.

NOW, THEREFORE, BE IT ORDAINED by the Taylorsville City Council that the 2026 Taylorsville City Council Meeting Schedule, attached hereto as Exhibit "A" and incorporated herein by this reference, is hereby adopted. The City Recorder, or her designee, is hereby directed and authorized to publish a copy of the attached 2024 Taylorsville City Council Meeting Schedule pursuant to UTAH CODE ANN. § 52-4-202(2).

This ordinance, assigned Ordinance No. 25-16, shall take effect as soon as it shall be published or posted as required by law, deposited and recorded in the office of the City Recorder, and accepted as required herein.
