3. PUBLIC HEARING THE PURPOSE OF THE MEETING IS TO RECEIVE INPUT FROM THE PUBLIC WITH RESPECT TO THE ISSUANCE OF THE BONDS AND ANY POTENTIAL ECONOMIC IMPACT TO THE PRIVATE SECTOR FROM THE CONSTRUCTION OF A FAIRGROUNDS FACILITY HOUSING AN ARENA, GRANDSTANDS AND RELATED STRUCTURES AND ACCESSORIES (THE “PROJECT”) TO BE FUNDED BY THE BONDS. ALL MEMBERS OF THE PUBLIC ARE INVITED TO ATTEND AND PARTICIPATE. THE INTENTION TO ISSUE LEASE REVENUE BONDS, IN A PRINCIPAL AMOUNT OF UP TO \$650,000 WITH INTEREST AT A RATE NOT TO EXCEED 2.0% PER ANNUM PAYABLE OVER A PERIOD OF NOT MORE THAN 35 YEARS (THE “BONDS”), PURSUANT TO THE BONDING ACT, TITLE 11, CHAPTER 14, UTAH CODE ANNOTATED 1953, AS AMENDED.

Mayor Trent Jackson advised those in attendance that funds being used for the building are going to be coming from the insurance company, the travel bureau and that we would be receiving \$2.475 million in grant monies from the CIB \$525,000 in loan at 1% interest for 30 years. The city is aware of the big concern going around on FB Community Page and felt that this needed to be addressed. The city had no plans to raise property taxes to pay for this building. The meeting will now be opened to the public.

Citizen Brad Clausen: Is there a total budget for the arena and these kinds of projects always seem to go over budget. *Mayor Trent Jackson responded that we are looking at a \$6 million dollar budget right now. The metal structure came in at 1.6 so that was under budget. We are hoping that we will continue to be able to come in under budget. Council Member Laramie Morgan responded that is why the building is divided into four different stages. Knowing that we can leave off the last one and still be a fully functional facility.*

Citizen Ryan Mills: When will the project be finished? *Mayor Trent Jackson advised that the hope was to*

have the building ready for July 2026. The City had to swamp building suppliers because the original building supplier kept pushing the date back when the metal building would be ready. With the new supplier the metal building should be here in February. The last meeting with Jones and DeMille and Ferron City just took place and the rest of the project should be going out to bid next Monday. Council Member Laramie Morgan stated that they are hoping that they would start with red iron first. They can come in and pour the footers and that way they can get the red iron up while they are building panels. That way, as they are delivering, it's all getting installed, that way we can hopefully stay on timeline.

Mayor Trent Jackson asked if there were any other comments from the public.
There was none.


