Welcome & Governance

Katie Mazzie, Chair

Katie welcomed the commission members. She recognized outgoing commissioners Deneiva Knight, Anna Smyth, Alexis Palmer, and Ben Trentelman for their terms of service.

Vice Chair Nomination

Jake discussed the nominating committee meeting and discussing candidates. The committee nominates Kim Hammer as Vice Chair for 2026.

Federal Funding Updates

Loggins discussed the end of the federal government shutdown and the implications for the commission. Loggins emphasized that the shutdown did not impact the Commission's ability to draw down funds. He discussed anticipated next steps and the need for continued monitoring.

2026 Strategic Planning Process

Loggins discussed the strategic planning process, including the plan for development and timeline over the next year.

Recent Events Updates

Mike discussed the National Governor's Association Service to Career Pathways, including how UServeUtah was involved during the Utah summit and the service project component.

Loggins discussed the Generation Volunteer Summit, including the engagement of the attendees. Mike emphasized the fundraising and philanthropic component of the event being highly successful.

Commissioner Activity

Cassidy Hansen led an activity asking the attendees to discuss a memory that happened during a specific year with another commissioner or staff, changing partners after each round to discuss multiple years.

Program Discussion

Loggins introduced the overview of each 50 minute breakout group and split the commissioners into two groups. Commissioners were excused, and the following breakout sessions took place.

After commissioners attended each breakout session, the commissioners attended the Power of Service Recognition where Virginia Ann Meldrum Maw was recognized for her long-term commitment to volunteerism in Utah.
