5:31pm Meeting Called to Order and Roll Call: Mayor Ann K. Leppanen, Jennifer Davila, Linda Sosa, Britt Hornsby, Spencer Wade & Erin Nelson, Town Manager

Public Comment:

Luanne Hook – Appreciation expressed to Town Council. A moment of silence for Joe Pachak and Gary Guymon. Appreciative that Town of Bluff has taken advantage of combining mobilization cost for the 7th West and 2nd East road construction project. Inquired why she did not hear about the construction via roads committee or active transportation committee but through residential email. She will present in January an update from the Active Transportation meeting. Encouraged council to reference Active Transportation Plan for all projects to slow traffic.

Amanda Lincoln – People speed down 2nd East although it is dirt, she would hate for it to become a space with more ability to speed. Wondering if the water flow has been taken into consideration. Material inquiry, Nelson responded that the material is 'crushed asphalt' is a gravel-similar surface. Hopeful that water flow has been addressed where the road becomes a river.

- 5. Discussion and Vote on Proposed Wildland Fire Cooperative Agreement (All) Removed due to same as Agenda item #4
- 6. Discussion and Vote on Jones and DeMille Notice to Proceed (Leppanen) (5:44pm):
 - Signature needed to begin work with Sonderegger, signed on Monday December 8, 2025.
 - Hornsby motions to approve Jones and DeMille Notice to Proceed, Davila seconded, Leppanen, Wade, Davila, Hornsby and Sosa voted in favor.
 - Davila and Hornsby will be in town and can coordinate this project while Nelson, Leppanen and Haviken are gone.
- 7. Discussion and Vote to Approve Work and Cost for Sonderegger Construction (Leppanen) (5:45pm):
 - Change order submitted from Sonderegger Construction presented with change in cost from \$49,530 to \$39,530. Installation of 5in of road base, 5in of gravel/crushed asphalt and improve drainage on 2nd East and East Black Locust.
 - Residents alerted to the work, Nelson reached out to Michael Haviken to ensure Bluff Water Works has been part of the project. Jones and DeMille have signed off on the project.
 - Hornsby motions to approve work and cost of \$39,530 for Sonderegger Construction,
 Davila seconded, Leppanen, Sosa, Hornsby, Davila and Wade voted in favor.
- 8. Discussion and Vote to Approve Work and Cost for Roadside Drainage and Shoulder Improvement at Corner of Twin Rocks Drive and Highway 191 for Helgerson Property Maintenance (Leppanen) (5:50pm):
 - Past couple of years Town of Bluff has paid road clean-up due to a drainage issue in preparation for the Bears Ears Marathon
 - Helgerson Property Maintenance completes the work and has requested the Town address their portion as he is also working with Twin Rocks property owner to solve the issue on their property. Cost: \$2200-\$2500
 - Hornsby motions to Approve Work and up to \$2500 for Roadside Drainage and Shoulder Improvement at Corner of Twin Rocks Drive and Highway 191 for Helgerson Property Maintenance, Davila seconded, Leppanen, Sosa, Hornsby, Davila and Wade voted in favor.
