A RESOLUTION BY THE OREM CITY PLANNING COMMISSION TO APPROVE THE SITE PLAN FOR THE **ORCHARD GROVE AFFORDABLE SENIOR HOUSING 4-PLEX** LOCATED GENERALLY AT 575 W 1700 NORTH IN THE R8 ZONE.

WHEREAS on November 3rd, 2025, the Housing Authority of Utah County filed an application with the City of Orem requesting the Planning Commission approve the site plan for Orchard Grove, an affordable senior housing 4-plex located at 575 W 1700 North in the R8 zone; and

- 2. The Planning Commission hereby approves the site plan for the Orchard Grove Affordable Senior Housing 4-Plex located generally at 575 W 1700 North in the R8 zone as shown on Exhibit "A" which is attached hereto and incorporated herein by reference.

- 4. If any part of this resolution shall be declared invalid, such decision shall not affect the validity of the remainder of this resolution.
- 5. All other resolutions or policies in conflict herewith, either in whole or part, are hereby repealed.


