2026 Regular General Election

I, Larinda Isaacson, Daggett County Clerk, State of Utah, do hereby certify that the following is a list of the offices to be filled at the regular general election to be held in the County of Daggett on Tuesday, November 3, 2026; the Declaration of Candidacy filing period for these offices begins on Friday January 2, 2026 at 8:00 a.m. and ends at 5:00 p.m., Thursday, January 8, 2026.

1. Federal

a. **U.S. House of Representatives.** One (1) Representative for a two (2) year term in each of the following U.S. Congressional Districts:

- i. Third District, which consists of Beaver, Carbon, Daggett, Duchesne, Emery, Garfield, Grand, Iron, Kane, Morgan, Piute, San Juan, Summit, Uintah, Wasatch, Washington, and Wayne Counties as well as portions of Utah and Weber Counties.

2. State

Utah Senate. One member for a four (4) year term from each of the following state senate districts:

- i. District Twenty (20) consists of Daggett, Duchesne, and Uintah Counties as well as portions of Summit and Wasatch Counties.

State House of Representatives. One member of the Utah House of Representatives for a two (2) year term:

- i. District Sixty-eight (68) consists of Daggett and Uintah Counties as well as portions of Duchesne and Summit Counties

3. Judicial

a. **Supreme Court.** There will be a retention election for two (2) Supreme Court Justices, provided that the incumbent(s) whose term is expiring files during the filing period.

b. **Court of Appeals.** There will be a retention election for six (6) Court of Appeals Judges, provided that the incumbent(s) whose term is expiring files during the filing period.
