Presented the Division's recommendations and answered questions from the RAC and public members.

RAC Questions:

- **Chuck Chamberlain:** How comfortable are you with the numbers of mountain lions?
- **Darren DeBloois:** Numbers are based on harvest data, always two years behind, we don't see kitten and yearlings too often on harvest. Good estimate of cougars on hand.
- **Chris Cannon:** If levels drop to a certain point, will we go back to a quota system?
- **Darren DeBloois**: There are two state laws the division is bound to follow, first anytime we detect predators in general effecting mule deer populations the director is required by law to enact predator management programs on those units. The second, we switched our management strategies and that again is state law. There are some things that the

- division could recommend the board do but as far as quotas, that would take a law change.
- **Austin Atkinson:** Collar studies on cougars, do we see cause specific mortality on a cougar? Do they die of starvation? What kills cougars?
- **Darren DeBloois:** Typically, hunter harvest is the #1 cause of mortality, natural is fairly low, starvation can occur. They do get killed by their prey and each other as well as roadkill.
- **Austin Atkinson**: What I am trying to understand is, are cougars dying because they are hungry since there is less deer?
- Darren DeBloois: Typically, yes, mirror the prey populations. Declines occur. A California study took 7-8 years to notice population reaction. They can prey switch, so sometimes that won't be affected by the decline in deer.
- **Austin Atkinson:** When we lost the permits for cougars, the fear was that the harvest would increase, it hasn't?
- **Darren DeBloois**: We had units that were unlimited harvest obj units prior to that, those were put in place due to the law that requires the director to act. About 2/3rds of the units were already unlimited. The biggest harvest year was the year before the change. Some areas inaccessible during winter months, these pockets supply lion surpluses.
- Austin Atkinson: Project 7707, WRI project, explain how that interacts with the unlimited cougar harvest for hunters with a license, trapping license, but this is a separate project. How is that harvest recorded? Do we have access to those numbers?
- Darren DeBloois: This is a research project; a touchstone of predator management is that predators do not affect prey population. Utah has 1000's of collars out and one thing we have noticed is that once lion predation on adult does goes above 7%, those populations will not grow. Experimentally look at some of those units where the criteria is above 7% mortality and see if we can answer that question. If you remove enough lions will that increase your deer herd?
- Austin Atkinson: How does that project come about?
- **Darren DeBloois:** We have been talking about it for a few years, is there a way to get this data. Other areas don't have the data set that Utah has on deer, they can't see it on that scale. We have the data and the capability to get the answer.
- Austin Atkinson: So we might be wrong about the study?
- **Darren DeBloois**: Compelling data, probably 9 units in the state that would meet the criteria of 7% adult doe mortality. That is based on collared deer data, so if 7% of your collared deer are being killed by lions, you probably have a lion issue. 9 units out of 30 cougar units.
- **Austin Atkinson:** How many cougars were taken on the Desert Bighorn Sheep Nursery Sanctuary?
- **Darren DeBloois:** 31 lion on 1800 acres. Study on the Nebo, 30 lions caught and still have uncollared lions showing up on their cameras.

- Name not given: Is this the government hunters killing the lions? How are they going to take those lions?
- **Darren DeBloois:** Yes, we are working with UDAF. I assume using any method they can. Snares, dogs. Snares probably most effective.
- Name not given: In the same areas that sportsmen are trying to hunt?
- **Darren DeBloois:** Yes, I don't know the timing. Year around. Traps are most effective in the summer or fall.
- Name not given: Did you say year round? Bears too?
- **Darren DeBloois:** That is my understanding, I don't know all the details. No, just lions.
- Name not given: You can't differentiate with snares and traps.
- **JJ Brewer:** Represents Utah Hounds association and self. Thank you for the process. Government hunters hired on how many units?
- **Darren DeBloois:** 6 units. Pine Valley, Monroe, Zion, Boulder, East Wasatch, Stansbury.
- **JJ Brewer:** We have already had a case of a hound being caught in a baited snare. Bait hanging in the tree, will bait sites be made public?
- **Darren DeBloois:** Not that I am aware of
- **JJ Brewer:** That is a lot of risk, hanging bait in a tree. Opens a lot of room for a non-targeted species to be caught. Specifically, dogs, hikers. Average hound 15k, there is a risk of us losing a hound, where is that funding going to come from for us?
- **Darren DeBloois:** Again, its public land, you will have to accept the risk at this point.
- **JJ Brewer:** I hate that answer. Why are houndsmen and sportsman not being called first?
- **Darren DeBloois:** I am not in the planning of that, I can't answer that question.
- **JJ Brewer:** Mothers and kittens are not currently allowed to be harvested, what is the protocol for these government sets? When a non-targeted animal like a mule deer buck get caught in one of these government sets?
- **Darren DeBloois:** If you are going to reduce a population, you are going to need to take females and kittens. Yes, an effort will be made to remove them but that is potential. One of the reasons we are using professional trappers.
- JJ Brewer: Where do these trappers come from? Who funded this study? Wasn't a public vote? Did this go through public RAC system or Wildlife Board?

- **Darren DeBloois:** Being funded by SFW and Wild Sheep Foundation. Utah state trappers are among the best in the state.
- Name not given: Last year I hunted bear on the Wasatch with a buddy, never experienced better bear hunting. This year, I drew the tag after 9 yrs. Spent 15-20 days never caught a bear. Weird because the year before had 2 in five days. I did some research, you guys and wool growers killed over 30 bears. If I did that I would be a felon. If there is that big a bear problem, why trappers rather than hunters? Why not let them hunt the summer?
- Darren DeBloois: Depredation take, trappers can only take bears out of active depredation situation. We committed to the Farm Bureau and wool growers that we won't grow predators on the backs of sheep farmers. We increased permits and quotas on the units?
- Name not given: Why don't we get the chance to hunt them? What are the trappers doing with the bears, throwing to waste?
- **Darren DeBloois:** Skin them out and salvage the parts, auction them later.
- Name not given: In 2023 66k deer tags across the State of Utah, 88K 2025. Deer herds have been struggling. Why killing all the lions when you are doubling deer tags? Why are you trying to save the deer and increasing the permits?
- **Darren DeBloois:** Remember, we hunt male deer. Managing to a buck to doe ratio. You can hunt deer and still grow deer populations. We manage to management plans.
- **Corby Fausett**: Thanks for everyone for being here. Is there a specific number on the 6 units, how many they want to see killed? When it was quota you could follow it that way.
- **Darren DeBloois:** Objective is to be really aggressive, get as many as we can. The tell will be what happens on the deer side.
- Corby Fausett: Collared does being killed, trapper heads there. If you
 can find the deer kill that's the golden nugget. High success rate running
 off of kills. Sportsman having opportunities. Killing the deer, coming back
 to eat what they killed and get snagged. We would love to help you out
 there. Money going to people in Utah's taxidermy and outfitting.
- Dan Riddle: Question about this bill, there's a term called confounding variables. Restricted weapons hunts implemented for data gathering. Can you speak to is there some confounding data? Are you skewing your own data?
- **Darren DeBloois:** The restricted weapons, implemented to determine what are the success rates. Can you hunt with lower tech weapons and still harvest? Allowing more opportunity for the hunters.
- **Dan Riddle:** Conflict of 2 different studies, with what the ultimate goal is more deer opportunity.
- **Darren DeBloois:** Clarifies comment, "public land, tough". Understands time and effort put into these dogs did not mean to come off as insensitive.

- **Dan Riddle:** Wool growers and SFW is that common to have outside representation funding?
- **Darren DeBloois:** Utah has incredible funding source, all sportsman organizations contribute millions of dollars that pays for habitat work, collars. Not unprecedented for that to occur.

 do? We feel like this did not come from DWR. Corrupt sportsman's
 groups and politicians. If coordinates were posted, we could stay away
 from it.
- Travis Jensen: Represents Wild Sheep Foundation. Thanks RAC for being here. I respect the difference of opinions. We support DWR in the study. These studies are not opinions, university level. Zion losing 25% adult sheep populations. Not a single sheep mortality due to disease on Zion. All 6 units chosen have adult deer mortality levels that do not support increasing deer numbers.
- JJ Brewer: Upset the way this has come about. Does not support sportsman fighting sportsman. We didn't get a vote. Again, this was backdoor polices. 3 of these units have wild sheep on them. Clint Mecham did a study on the Monroe mountain 1996-2013. We killed 40 mountain lions, the data is out there. McClean Mecham was doing the same study on the Oakers. We harvested no lions. Reduced permits from 40 to 5. If killing the lions is going to bring back our deer herds, why didn't it do it in 2022-2024 on the Monroe mountain or when we did the study for 17 years? Statement from that study, Utah State University, Cougar population response "Interestingly enough, the Monroe study itself suggests that human hunting of cougars was non-compensatory

additive for the cougar population. Meaning hunting significantly reduced cougar numbers but this did not automatically translate into a net survival gain for more deer. Closing statement of the study intense line and harvest and control the mountain lions have shown to be, no help to grow the deer population." Biggest point, this should have been voted on in public process, two conservation groups should not get to decide.

- Hadli Sorenson: Wild sheep foundation. At the core of our position is a
 is a firm belief in science-based wildlife management, ultimately guided
 by credible peer reviewed data.
- Hunter Mecham: Monroe is completely burned and the Boulder got habitat work approved. BYU study showed it is a habitat problem on the Boulder. Darren already said that lion numbers have dropped and deer haven't exploded. We don't need to spend \$300,000 on a study. Put money into highway work. Ten dead deer between Tropic and Richfield on the drive.
- **Kasey Yardley:** There are good people on both sides of this. I am a lion hunter, from a family of ranchers. Sheep foundation and SFW will make the decisions, they are calling the shots. It's not right that you can take sheep and put them on the west desert and buy out all the sheep permits then put your sheep out there, that get a sniffle and die. Why can't we do this the right way? This is a money deal, that is all it is.
- **Troy Henrie:** Utah Farm Bureau supports this study. Important to get hard data.
- **Will Talbot:** Piute County Commissioner and a rancher on Boulder mountain, ran sheep on Monroe mountain. Been on Boulder mountain for 18 years, losses from 100 for many years and now 300 to 400 per year. We support this.
