## **RESOLUTION NO. 26-01**

### **A RESOLUTION OF THE CITY OF TAYLORSVILLE APPOINTING DAVID YOUNG TO THE PLANNING COMMISSION AS A DISTRICT NO. 1 REPRESENTATIVE.**

**WHEREAS**, the Taylorsville City Council (the “Council”) met in regular session on January 7, 2026, to consider, among other things, appointing David Young to the Planning Commission as a representative of District No. 1; and

**WHEREAS**, TAYLORSVILLE MUNICIPAL CODE §13.03.030(A)(2)(a) directs that members of the City’s Planning Commission are to be appointed by the City Council; and

**WHEREAS**, TAYLORSVILLE MUNICIPAL CODE §13.03.030(A)(2)(b) states that Planning Commission members serve a four-year term; and

**WHEREAS**, David Young has served as an Alternate member of the Planning Commission since January 5, 2022; and

**WHEREAS**, the City desires to appoint David Young to the Planning Commission as a representative of District No. 1 to fill the unexpired term of former Commissioner Don Quigley to end June 30, 2026; and

**WHEREAS**, after careful consideration, the Council has determined that it is in the best interest of the health, safety and welfare of the City’s citizens to appoint David Young to the Planning Commission as a District No. 1 representative to fill the unexpired term.

**NOW, THEREFORE, BE IT RESOLVED** by the Taylorsville City Council that David Young is hereby appointed to the Planning Commission as a District No. 1 representative.

This Resolution, assigned Resolution No. 26-01, shall take effect immediately upon passage and acceptance as provided herein.
