**Background:**

Instructional Materials for Child Sexual Abuse and Human Trafficking Prevention are required by 53G-9-207 to be submitted to the Board for approval prior to their use in schools. The materials are submitted through the Recommended Instructional Materials System (RIMS) and they are then reviewed by a review committee to ensure compliance with the minimum guidelines. The Fall 2025 materials review cycle has concluded, and materials have been reviewed by the review committee are now being submitted by prevention staff for approval to the Board.
