### **RESOLUTION 2026.XX**

A RESOLUTION APPROVING THE DESIGNATION OF THE MAYOR TO SERVE AS TOQUERVILLE CITY'S REPRESENTATIVE ON VARIOUS BOARDS, COMMITTEES, AND ORGANIZATIONS FOR THE 2026 THROUGH 2029 MAYORAL TERM OR UNTIL SUCH TIME AS A SUCCESSOR HAS BEEN APPOINTED.

#### **RECITALS**

WHEREAS, Toquerville City participates in and is represented on various boards, committees, and regional organizations that provide services, coordination, planning, and advocacy affecting the City and its residents; and

WHEREAS, such boards and committees require formal designation of representatives by participating municipalities; and

WHEREAS, the Mayor of Toquerville City customarily serves as the City's representative on certain boards and committees; and

WHEREAS, it is necessary and desirable for the preservation of the public health, safety, and welfare to designate the Mayor to serve on the boards and committees identified herein;

#### **RESOLUTION**

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF TOQUERVILLE, UTAH, AS FOLLOWS:

1. Appointment. The Toquerville City Council hereby designates Mayor Dan Catlin to serve as Toquerville City's representative for the 2026 through 2029 mayoral term, or until such time as a successor has been designated and appointed, on the following boards, committees, and organizations:

1. Ash Creek Special Service District - Board of Directors
2. Washington County Council of Governments (COG)
3. Dixie Metropolitan Planning Organization - Dixie Transportation Executive Council (DTEC)
4. Washington County Water Conservancy District - Administrative Advisory Committee (AAC)
5. Utah League of Cities and Towns - Legislative Policy Committee (LPC)
