### DIVISION OF WATER QUALITY UTAH DEPARTMENT OF ENVIRONMENTAL QUALITY PUBLIC NOTICE OF UPDES PERMIT MODIFICATION

#### **PURPOSE OF PUBLIC NOTICE**

The purpose of this public notice is to declare the Director of the Division of Water Quality's intention to modify a Utah Pollutant Discharge Elimination System (UPDES) Permit under the authority of the Utah Water Quality Act, Utah Code § 19-5-106(2)(g). The draft Permit and the Fact Sheet (collectively, the draft Permit documents) are available for review and comment.

#### **BACKGROUND**

This is a temporary construction project to install new sewer utility pipelines for Salt Lake City. The new sewer line will be installed from the 1800 North/Chicago St. intersection along Chicago St. to a trenchless crossing under I-15 and the railroad and across Rosewood Park to 1200 West. The Permittee is requesting a change in outfall location for Outfalls 001 and 002. Only these modifications are available for comment during this Public Notice.

#### **PUBLIC COMMENTS**

Pursuant to Utah Admin. Code R317-8-6(6.6), any interested person may submit written comments on the draft permit documents and may request a public hearing if no hearing has already been scheduled. A request for a public hearing shall be in writing and shall state the nature of the issues proposed to be raised in the hearing. All comments will be considered in making the final decision and shall be answered as provided in Utah Admin. Code R317-8-6(6.12).

Supporting material must be included in full and may not be incorporated by reference, unless the material is already part of the administrative record.
