MOTION: Rep. Walter moved that Under Joint Rule 3-2-101 and 3-2-402, legislative staff be authorized to include in the base budget bill for the Higher Education Appropriations Subcommittee the following recommendations to the Executive Appropriations Committee: 1. The accountable process budget changes adopted earlier today and in this interim; 2. Ongoing General Fund and Income Tax Fund appropriations defined in the current year's appropriations acts; 3. Federal Fund, Dedicated Credit, and Restricted fund and account amounts that are the lesser of current year ongoing appropriations or agency budget requests; 4. Adjustments to Nonlapsing balances, transfers, and other dependent amounts as calculated; and Line-item performance measures included in FY 2026 appropriations bills with any changes made earlier today and in this interim. In consultation with the Co-Chairs of the Appropriations Subcommittee, staff may make any technical changes necessary, including balancing between the General Fund and Income Tax Fund, if applicable, to balance the overall budget. The motion passed with a vote of 10 - 0 - 7.
