

ORDINANCE 2026-2

AN ORDINANCE AMENDING THE ORANGEVILLE CITY CODE TO ADOPT UPDATED AND ACCURATE CROSS-REFERENCES TO THE UTAH STATE CODE

WHEREAS, Orangeville City (“City”) is authorized to enact ordinances necessary for the health, safety, and welfare of its residents pursuant to Utah Code §10-3-701; and

WHEREAS, the City Code contains references to provisions of the Utah Code that have been renumbered, amended, or repealed by the Utah Legislature; and

WHEREAS, accurate statutory cross-references are necessary to ensure correct interpretation, enforcement, and consistency with state law; and

WHEREAS, the City desires to amend the Orangeville City Code to update and adopt accurate citations to the current Utah Code;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF ORANGEVILLE CITY, UTAH:

SECTION 1. PURPOSE AND INTENT.

The purpose of this ordinance is to update, correct, and adopt accurate cross-references to the Utah Code throughout the Orangeville City Code. This ordinance does not alter the substantive meaning or enforcement of any provision and is limited strictly to the correction of citations and numbering references.

SECTION 2. AMENDMENT TO ORANGEVILLE CITY CODE.

A. All references within the Orangeville City Code to provisions of the Utah Code that have been renumbered, amended, or otherwise changed are hereby revised to reflect the correct and current Utah Code citations as adopted and published by the Utah Legislature.

B. Wherever the City Code refers to a Utah Code section that has been:

1. **Renumbered**, the reference shall be updated to the current section number;
2. **Reorganized**, the reference shall be updated to the current title, chapter, or part designations;
3. **Repealed and replaced**, the reference shall be updated to the successor statute with equivalent subject matter;
4. **Amended**, the reference shall be interpreted and applied consistent with the current Utah Code language.

C. The City Recorder is authorized to incorporate these corrected citations into the published City Code.

SECTION 4. SEVERABILITY.

If any provision of this ordinance is found to be invalid by a court of competent jurisdiction, the remaining provisions shall remain in full force and effect.

SECTION 5. EFFECTIVE DATE.

This ordinance shall become effective immediately upon passage and posting as required by Utah law.
