# Purpose

Goal: Provide an overview of the Draper City Comprehensive Emergency Management Plan

## Objectives:

- Outline the framework for managing disasters and major emergencies
- Identify departmental responsibilities and coordination



# Legal Authorities

## CEMP Developed in Compliance:

- FEMA Comprehensive Preparedness Guide 101
- Utah Code §53-2a-1403
- National Incident Management System (NIMS)
- Incident Command System (ICS)

## Purpose:

Establishes Draper City's framework to coordinate emergency response, recovery, preparedness, and mitigation operations.





# Scope of the Plan

## Applies:

- All Draper City departments and divisions
- Coordination with County, State, and Federal Agencies
- Integration with Salt Lake County Emergency Management and Utah Division of Emergency Management

## Based On:

- Salt Lake County Hazard Mitigation Plan and Draper City Risk Profile





# Plan Objectives

- Establish scalable command and control structures
- Define operational procedures across all departments
- Identify key roles, responsibilities, and resources coordination
- Support continuity of government and operations
- Build community preparedness and resilience





# Concept of Operations

## Operational Priorities:

1. Life Safety
2. Incident Stabilization
3. Property & Environmental Protection
4. Community Lifeline Stabilization
5. Continuity of Government





# Preparedness Activities

## Draper City Focus Areas:

- Regular plan updates and Continuity of Operations Plan integration
- Training and exercises (HSEEP compliant)
- Baseline FEMA ICS/NIMS training for staff
- Public education and outreach





# Response Operations

## Key Actions:

- Establish a common operating picture
- Coordinate public information via JIC
- Conduct damage assessments
- Request mutual aid and resources
- Support community protective actions and evacuations





# Recovery Operations

## Transition from Response to Recovery:

- Hazard contained/lifelines stabilized
- Initial damage assessments completed

## Recovery Task Force (RTF):

- Coordinates recovery priorities
- Activates Recovery Support Functions (RSFs)
- Develops Long-Term Recovery Plan





# Implementation and Maintenance

- Reviewed annually by Draper City Emergency Management
- Updated every three years or post-incident/exercise with lessons learned
- Integrated with department Continuity of Operations Plans
- Continuous improvement through After-Action Review





# Logistics Annex

## Purpose:

- Ensures responders have the people, equipment, facilities, and supplies needed to operate
- Supports all City departments during emergencies and planned events

## Applies to:

- Short-duration incidents
- Extended, multi-day emergencies
- Large-scale evacuations and disasters



# Core Capabilities

- Resource request, ordering, and tracking
- Staging areas, facilities, and responder support
- Transportation and shelter support
- Vendor, mutual aid, and partner coordination
- Integration with County and State logistics systems
