- **Telephone roll call**

 - Reed presented the accounting report, and offered to answer any questions the board may have.

- Randy reported that 23 of the 25 bail agencies successfully renewed their licenses on time.
- Two agencies let their licenses lapse:
 - AA Rocky Mountain Bail Bonds
 - Pappas Bail Bonds
- Pappas later applied for reinstatement.
- o Bail bond agency reinstatement: Pappas Bail Bonds / Randy
 - *Timestamp 05:25*
 - Randy described the actions and qualifications Pappas has completed to apply for reinstatement.
 - Randy said Pappas qualifies for reinstatement, and the UID is seeking concurrence from the BBOB.
 - Reed noted that the BBOB does not have to take action on renewals, but the statute does say they need to concur on a reinstatement.
 - **Motion by Jon to reinstate the agency license of Pappas Bail Bonds. Seconded by Theodore. Motion passed 5-0.**
 - YEA: Michelle, Mike, Bonnie, Jon, Theodore
 - NAY: None
- **Old Business**
 - o Bail bond board membership / Reed
 - *Timestamp 9:14*
 - Reed Stringham addressed a potential issue with board membership. Currently, two members — Bonnie Johnson and Mike Weddington — represent the same agency: Beehive Bail Bonds.
 - The UID determined this is not an issue because the requirement for representation from separate agencies only applies at the time of appointment. At the time of her appointment, Bonnie Johnson was with AA Rocky Mountain, which is no longer in business.
 - Mike Weddington stated he would be willing to step aside if another board member could be found.
