

## RESOLUTION NO. 25-15

### A RESOLUTION ADOPTING THE ANNUAL MEETING SCHEDULE OF THE COUNTY COUNCIL OF WASATCH COUNTY FOR THE CALENDAR YEAR 2026

**WHEREAS**, any public body which holds regular meetings that are scheduled in advance over the course of a year shall give public notice at least once each year of its annual meeting schedule, pursuant to Utah Code Ann. 52-4-202; and

**WHEREAS**, the public notice shall specify the date, time and place of such meetings, pursuant to Utah Code Ann. 52-4-202; and

**WHEREAS**, to provide consistency and public notice to the citizens of Wasatch County the County Council of Wasatch County should adopt an annual meeting schedule for the calendar year 2026; and

**WHEREAS**, the County Council of Wasatch County finds, for the above stated reasons, that it is prudent and necessary that an annual meeting schedule for the calendar year 2026 be adopted:

- E. This annual meeting schedule is subject to change in the event circumstances so require. Any meeting held on a date not in conformity to this annual meeting schedule will be noticed in accordance with Utah law.
- F. After this Resolution is adopted, signed by the Chairman and attested by the County Clerk, it shall be recorded in a book kept for that purpose, and shall take immediate effect.
