ORDER GRANTING JOINT MOTION TO  
VACATE SCHEDULING ORDER

ISSUED: January 9, 2026

On January 8, 2026, the Division of Public Utilities (DPU) and the Office of Consumer Services (OCS) filed with the Public Service Commission (PSC) a Joint Motion to Vacate the Scheduling Order and for Expedited Treatment (“Motion”). The Motion requests the PSC vacate the scheduling order issued November 4, 2025 (“Scheduling Order”).

On January 7, 2026, a representative of applicant LTE Wireless INC (“Applicant”) filed a request to withdraw Applicant’s application in this docket. That request, however, was deficient and the PSC requested Applicant to cure these deficiencies so that it could be properly before the PSC for consideration (“PSC Request”). On January 9, 2026, Applicant filed a Second Request to Withdraw its Petition for Designation as an Eligible Telecommunications Provider.

The Scheduling Order establishes a deadline of January 9, 2026, for DPU and OCS to file their respective testimony in this docket. However, in light of the possibility that Applicant’s January 7 and January 9, 2026, requests to withdraw its application in this docket may still be properly considered, the testimony of DPU and OCS may be unnecessary.
