- **Meeting Notice:** Notice and the official agenda for each meeting will be publicly posted at least 24 hours in advance.
- **Public Access:** Meetings are open to the public, with the exception of legally authorized closed sessions.
- **Minutes Availability:** Detailed minutes will be officially recorded and made publicly accessible following their approval.
