RESOLUTION 2026-09

A RESOLUTION RELEASING AND APPOINTING MEMBERS OF THE STAKEHOLDERS COUNCIL

WHEREAS, Article VII of the 30 May 2017 “Central Wasatch Commission Interlocal Agreement” (the “CWC *ILA*”) provides that the governing body (the “*Board*”) of the Central Wasatch Commission interlocal entity (the “CWC”) will empanel an advisory body to the Board to be known as the “Mountain Accord Stakeholders Council” (the “*Council*”) comprised of 28-35 individuals and entities that have a direct interest in the objectives of the CWC (“*Stakeholders*”); and

WHEREAS, in December 2018 the Board appointed the inaugural Council and thereafter released, appointed and reappointed various members of the Council; and

WHEREAS, on 12 January 2026 the Board met in regular session to consider, among other things, (a) releasing **Pat Shea** and **Ian Reddell** as members of the Councill (b) appointing **Jen Melton** and **Brendan Smith** as new members of the Council; and (c) ratifying and confirming the current membership of the Council; and

WHEREAS, the Board has determined that it will be in the best interests of the CWC to so act;

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Central Wasatch Commission that the Board hereby consents to the releases and appointments described above and hereby consents to, confirms and ratifies the status of the following individuals as all the members of the Council for the terms of office set forth opposite each name:
