**ITEM 1: CALL TO ORDER**

Mayor Jeppsen welcomed everyone and called the City Council meeting to order.

**ITEM 2: PROCEDURAL ISSUES**

**A. Conflict of Interest Declaration**

**ITEM 3: PUBLIC HEARINGS**

**A. Ordinance 25-X Boundary Adjustment with Willard**

City Administrator Bob Barnhill provided background on the boundary adjustment with Willard City. The ordinance would move properties from Willard City into Perry City, straightening out the boundary between the two cities and allowing property owners to have access to utilities already in the adjacent roadway. He noted that the process was initiated by Lync Construction, which owns three large parcels in the area.

Mr. Barnhill explained that as these properties come into Perry City, they would need to be assigned zoning districts. Lync Construction had requested R-1/3 zoning, but there were other property owners whose preferences needed to be considered. Mr. Barnhill displayed a map showing the current city boundary and the proposed adjustment.

**B. Resolution 2025-25 Amending the Fiscal Year 2025-2026 Budget**

Financial Director Shanna Johnson presented a budget amendment to add \$63,225 for police dispatch services. She explained the annual total for these services is \$101,885 with an automatic 3.5% increase each year, but the city would only pay for about half of it this year plus some transmitters and transitional items. This would bring the budget to \$6,804,353.86.

**The public hearing was opened at 6:42PM.**

James Settemire stated he was in favor of the boundary adjustment as it would clean up the boundary line. However, he noted that his property is almost 2 acres and requested zoning that would allow him to have animals. He expressed concern about being arbitrarily zoned for third-acre residential.

Chad Braegger clarified that the properties are currently zoned for 3-5 acres in Willard. He suggested R-1A zoning to allow for some agricultural use, noting he plans to keep his property in Greenbelt. He mentioned he was working with the developer on a land swap to create a buffer behind his house.

Jeannine Jensen expressed concern about approving the annexation without identifying lot sizes, noting there were already 75 townhomes being constructed nearby. She wanted to preserve the rural feel of the area.

**The public hearing was closed at 6:50PM.**

**ITEM 4: ACTION ITEMS**

**A. Ordinance 25-X Boundary Adjustment with Willard**

The Council discussed zoning options for the properties being moved into Perry. Council Member Young supported zoning the entire area with R-1A. Council Member Walker suggested R-1/2 as appropriate for most of the area but supported R-1A for the Settemire, Braegger, and Barker properties. Council Member Tueller agreed with this approach and recommended maintaining 8 units of multifamily housing in the density map for the area.

Mr. Barnhill clarified that the Council had complete discretion in determining zoning for these properties. Council Member Ostler raised questions about animal rights in different zones and ensuring the exhibits were properly attached to the ordinance.

**MOTION:** Council Member Tueller made a motion to approve Ordinance 25-X with the Settemire, Braegger, Barker and UTA properties zoning at R-1A and the Lync properties zoning at R-1/2 with 8 multifamily units available in the density map and ensuring that all exhibits and dates are properly attached. Council Member Walker seconded the motion.



**Motion Approved. All Council Members were in favor.**


