- **Plat Amendment - Cove Estates Plat J - Located approximately at 1030 North 1510 East**

Rebecca Gourley introduced the Cove Estates Plat Amendment. The purpose of the plat amendment is to alter the existing PUEs and combine the lots located at 1030 North 1510 East and 1006 North 1520 East. Both lots abut one another, are zoned R12, and are located on cul-de-sacs. The combination of the lots will result in a double frontage lot. All PUEs are to remain the same, with the exception of the PUE that is located along the current shared backyard property line; All utilities, with the exception of Comcast, are to be vacated from the PUE located along the backyard property line.

Staff noted that the amendment would result in less traffic for the cul-de-sac at 1510 East. Aaron McKnight commented that the final printed mylar must have a note confirming the property meets double frontage lot requirements.

The DRC had no further comments. Jared Hall requested a motion.

**DRC Action:** Taylor Taggart motioned to recommend a positive approval of the Cove Estates Plat J Plat Amendment to the Planning Commission. Chelsea Lindsey seconded the motion.

DRC members reviewed the plat and found it to be compliant with City Code. The DRC had no further comments. Jared Hall requested a motion.
