## **CEMETERY DONATION-BRUCE DART**

Bruce Dart attended the meeting to see if the council would like to have a kneeling soldier placed in the cemetery. He suggested that the soldier be placed by the flag or at the corner of the cemetery as you drive in. The members of the Legion Hall are also interested in helping fund the monument. Alan inquired about how much room the monument will take. Bruce will take the responsibility to get donations to pay for the monument and if there are not enough donations, Bruce will pay the rest. Bruce would also like to put up a bronze Plaque that would have a list of all the US conflicts. Bruce also wanted to know if there were any confederate soldiers buried in the Myton Cemetery. Mayor Cooper stated that there are rumors that there are few but there is no documentation of any confederate soldiers buried there. Harold Crapo explained that there is a relative of his that is buried there from the war. Mayor Cooper explained that there is some money that has been given to the city to help preserve Myton history. Mayor Cooper also suggested that she get Richard Depp from the newspaper to come and write a story about raising the funds for the kneeling soldier. Harold Crapo and Brooke Liddel voiced their interest in having the monument put into the cemetery. The American Legion is interested in getting involved in helping with funding the statue.

## **RIGHT OF WAY AGREEMENT FOUR POINTE RESOURCES- CHRISTIAN HATCH**

Christian Hatch came to the council to explain about what the Right of Way and proposed a second agreement for an easement. This pipeline will help move water around and it will be a permanent pipeline that will be buried. There will be 40 feet permanent area for the pipeline. Because it will be put on Myton City property Four Pointe will pay Myton City an amount that is based on the value of the property. With an .85 acre with a one-time payment of \$6,730.56 for the right of way. Alan Allred enquired about where exactly the pipeline will run through. Christian Hatch explained that he will send a map to Alan so he can see exactly where it will be placed. Christian Hatch said that all the work will be done by a vetted contractor.

Alan wanted to know if any of the placements on the pipe will interfere with anything that is in Myton. Mayor Cooper said that all this information will be sent to the attorney and then the council can get back with Christian Hatch and let him know what the attorneys have said. Christian Hatch said that if there is any questions we can contact him or Zane. Christian Hatch also said that Four Pointe would like to donate to the memorial for the cemetery.

Mayor Cooper explained that they send this to the council to have it reviewed and motioned upon the budget.

## **CITY DEPARTMENTAL REPORTS ON LAST MONTH’S ACTIVITIES**

**Carrie Boren: stated** that the statue for the cemetery has been paid for and ordered.

**Alan Allred:** announced that he has found that some of the Christmas lights are not lighting up. He believes that there is a possible power issue. Alan Allred said that they do have some lights that are more colorful and they will put them in the decorations next year. Alan stated that they will be doing some touch-up painting in the Myton City building. Michael “Chipper” Fenn was wondering if more lighting can be put in to help light up the back parking lot. Alan Allred said that they are looking into getting more lighting in the back parking lot. Herold Crapo wanted to know if they could put up a yard light, but Alan Allred believed that there is not enough power to put a yard light up. Mayor Cooper would like Alan Allred to investigate putting a yard light in the back parking lot.

**Mayor Cooper:** stated that there are flags along the highway that are tattered and she would like them replaced with new flags.

**Larry Dye: Voiced** his concerned that there are some yard lights that are out and he would like Moonlake Electric to fix them.

**Mayor Cooper:** stated that she would like to thank everyone for the many years of service.

Sunrise has nothing to say in this session but has come to hand out gift cards to the members and Michael “Chipper” Fenn expressed his thanks to all the members that he has worked with for the past years. Carrie Boren explained that the Wells Fargo account has been closed and that is the reason why they need to sign some of the pages.
