Reports

Council (Melodi)

- Meeting yesterday, on YouTube, mayor reported the State of the City - everything accomplished in the last eight years
- ribbon cutting for Central States (sheeting material) at the Peterson Depot today
- JB Hunt will also be here in Tooele
- Founders Pointe opening stores, Smith's will open in December

Director (Chase)

- Summer reading was a success!
- Hitting pre-covid numbers of visitors
- Fully staffed
- Building/grant projects - no current grants (a lot depend on federal funding), CLEF grant is funded by state (about \$9,000)
- Canopy is done! Improved safety for staff, added another book drop because it was filling up during the weekend.
- Xeriscaping by parking lot (on north side) starting soon
- Haunted Historic Park - coming up in mid-October, big event for the library

- New Board Members - Kalani Mascherino, Jesi Lloyd, and Denece Hall
  - Introduced ourselves
- Voting for New Chair, Vice Chair, and Secretary
  - Kalani nominates Denece Hall for Chair, Crystal seconds. All in favor.
  - Denece nominates Kalani Mascherino for Vice Chair, Chennelle seconds. All in favor.
  - Crystal nominates Julie Brough for Secretary, Kalani seconds. All in favor.
- Policy Changes
  - New Policy - Privacy Policy
    - Will likely be required by the state - they asked if we have one, so a policy is being created to anticipate one being required down the road - has been reviewed by the city attorney and IT
    - Kalani motions to approve, Denece seconds. All in favor.
  - Internet Access and Computer Use Policy

- Change - includes wording for CIPA, added a section for COPA (librarians don't help set up accounts for anyone under 13 that involves two-way communication)
- Crystal motions to approve changes, Kalani seconds. All in favor.
- Lost and Found Policy
  - Change - clarifying that beverage containers that will be thrown away immediately are disposable ones
  - Crystal motions to approve change, Jesi seconds. All in favor.
- Standards of Conduct Policy
  - Changes - patrons can't provide false information (i.e., lying about age to get into programs, lying about address to avoid non-resident fee), appeal process for patrons that have been expelled (one per calendar year and at least six months since the expulsion)
  - Kalani motions to approve changes, Denece seconds. All in favor.
