

## PARKS, TRAILS, AND RECREATION COMMITTEE MINUTES

**Wednesday, November 5, 2025 at 7:00 PM** at 1020 East Pioneer Road, Draper, Utah 84020 in the Administration Conference Room.

1. **Approval of 9-3-2025 & 10-1-2025 Minutes**– Motion by Geneva Woodmansee, seconded by Keri Brown, to approve the minutes. Motion passed unanimously.
2. **Approval of the 2026 Parks, Trails, and Recreation Committee Meeting Schedule** – Motion by Geneva Woodmansee, seconded by Doug Anderson, to approve option 2 schedule, in which meetings will be held the first Wednesday of every other month, on the odd months, at 7pm. Motion passed unanimously.
3. **Rattle n' Hum Trail Connection to Woods Hollow Trail** – Brad reviewed potential trail alignments. Motion by Jamie Pogue, seconded by Doug Anderson, to follow the lowest (green) alignment that ties into Woods Hollow Trail. Motion passed unanimously.
4. **West Red Rock Access Trail Proposal** – Brad reviewed proposed trail loop alignment to provide access to west climbing rocks. Motion by Geneva Woodmansee, seconded by Doug Anderson, to recommend the proposed trail loop as presented. Motion passed unanimously.
5. **Maple Hollow Downhill Trail & Ann's Trail Crossing Improvement Option** – Brad and Greg reviewed a simplified trail crossing alignment that would accommodate a future fly-over. Motion by Jamie Pogue, seconded by Geneva Woodmansee, to recommend the proposed trail alignment and trail crossing as presented. Motion passed unanimously.
6. **Committee/Staff reports**

Brad Jensen stated that there is some movement on the development of the BST-East alignment, from Longview Trail to Three Falls Trail, with involvement from the Corner Canyon Trails Foundation, and a developer in Alpine. Mike Green to reach out to his contact at Entrata (land owner) to help secure approvals.

Greg Hilbig reviewed some additional efforts, including signage, to restrict equestrian use on Fango and Longview Trails during the winter and spring months.

Rhett Ogden discussed the city's plans to organize a bike race for next June at Brookside Trailhead. He requested the committee's assistance. The committee supports this event.

General discuss about the city should consider a parking fee program, using a fee kiosk, at all trailheads.
7. **Adjournment** - Motion by Jamie Pogue, seconded by Geneva Woodmansee to adjourn the meeting. Motion passed unanimously.
