**A RESOLUTION OF THE TOWN COUNCIL OF VIRGIN, UTAH, APPOINTING A  
REPRESENTATIVE TO SERVE ON THE ADMINISTRATIVE CONTROL BOARD OF  
WASHINGTON COUNTY SPECIAL SERVICE DISTRICT NO. I**

**WHEREAS**, Washington County Special Service District No. I ("District") is a special service district organized under Title 17D of the Utah Code for the purpose of providing solid waste collection and disposal services within Washington County, Utah; and

**WHEREAS**, pursuant to Utah Code§ 17D-1-301, the District is governed by an Administrative Control Board ("Board") whose members are appointed by the Washington County Commission with input from the participating municipalities; and

**WHEREAS**, Virgin is a participating municipality within Washington County which receives services from the District and is entitled to representation on the Board; and

**WHEREAS**, Virgin desires to designate a member of its governing body to serve on the Board, with such appointment becoming effective only upon approval and formal appointment by the Washington County Commission as the governing authority of the District; and

**WHEREAS**, Virgin further desires that the appointment shall continue until: (a) the appointee's municipal term of office expires, (b) Virgin designates a replacement by subsequent resolution, or (c) until expiration of the term of appointment fixed by resolution of the Washington County Commission, whichever first occurs.

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE TOWN COUNCIL OF VIRGIN,  
UTAH, AS FOLLOWS:**

1. **Appointment.** The Virgin Town Council hereby designates Jean Krause, a duly elected member of the governing body, to serve on the Administrative Control Board of Washington County Special Service District No. I.
2. **Effective Date of Appointment.** This designation shall become effective upon approval and appointment by the Washington County Commission, acting as the governing authority of the District.
3. **Term of Service.** The appointee's term shall continue until (a) the appointee's municipal term of office expires, (b) Virgin designates a replacement by subsequent resolution, or (c) until expiration of the term of appointment fixed by resolution of the Washington County Commission, whichever first occurs
