**A Resolution of the Town Council of Virgin, Utah, Approving and Authorizing a Lease
Agreement for BMX Track Located at 425 N. Kolob Terrace Road**

WHEREAS, the Town of Virgin (the “Landlord”) is the owner of a certain ten-acre tract of real property located at 425 N. Kolob Terrace Road, Virgin, Utah 84779, also known as Assessor Parcel No. V-2-1-23-411 (the “Track Property”); and

WHEREAS, the Track Property contains improvements, including a gravel parking lot, various buildings, structures, and fences ancillary to an earthen BMX racetrack and an earthen BMX pump track, which are the central features of the Track Property (collectively, the “Track Improvements”); and

WHEREAS, Tenant desires to lease the Track Property from Landlord under the terms and conditions set forth in a written lease agreement; and

WHEREAS, Landlord desires to lease the Track Property to Tenant under the terms and conditions set forth in the written lease agreement; and

WHEREAS, the parties desire to enter into a written Lease defining their respective rights, duties, obligations, and liabilities relating to the lease of the Track Property; and

WHEREAS, the Town Council of Virgin, Utah, has reviewed the proposed Lease and finds that entering into the Lease serves a valid public purpose and is in the best interest of the Town; and

WHEREAS, the Town Council desires to authorize the Mayor of the Town of Virgin to sign and execute the Lease agreement on behalf of the Town;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF VIRGIN, UTAH, THAT:

1. Approval of Lease.

The Lease agreement between **Virgin Town** as Landlord and **Michael Linares** as Tenant, concerning the BMX Track Property located at 425 N. Kolob Terrace Road, substantially in the form presented to the Town Council, is hereby approved.

2. Authorization to Execute.

The Mayor is hereby authorized and directed to sign and execute the Lease on behalf of the Town, and the Town Recorder is authorized to attest thereto.

3. Effective Date.

This Resolution shall take effect immediately upon adoption.
