**A Resolution of the Town Council of Virgin, Utah, Approving the Integrated Preparedness Plan (IPP) and Continuity of Operations Plan (COOP)**

**WHEREAS**, Emergency Manager Randy Hiller has brought to the attention of the Town Council the need to update various emergency management plans and adopt them prior to submission to Washington County and the State of Utah; and

**WHEREAS**, the Town Council has reviewed draft versions of the Integrated Preparedness Plan (IPP) and the Continuity of Operations Plan (COOP), which supplement the Town's existing Emergency Operations Plan (EOP); and

**WHEREAS**, the IPP outlines preparedness priorities, identifies collaborative partnerships with area agencies, evaluates town threats, hazards, and risks, and provides guidance for supportive training; and

**WHEREAS**, the COOP ensures that the Town can maintain and resume operations following an emergency, including delegating authority and establishing an order of succession among Town officials; and

**WHEREAS**, adoption of the IPP and COOP is required by the County and State for the Town to access emergency resources and grant funding.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF VIRGIN, UTAH, THAT:**

1. The Town Council hereby approves the Integrated Preparedness Plan (IPP) and Continuity of Operations Plan (COOP) as presented.
2. The Town Council authorizes the Mayor and Town staff to submit these plans to Washington County and the State of Utah as required.
3. This Resolution shall take effect immediately upon adoption.
