**2.1. City Council Listening Session for Vineyard Interfaith and Non-Profit Organizations**

Councilmember Holdaway will facilitate a listening session for the purpose of gathering input and exploring collaboration in the following areas:

- Strengthening a **compassionate community response**, including ways faith-based groups can provide practical support to first responders during emergencies

- Opportunities to better involve **faith-based and non-profit organizations** in City events, such as the Christmas Tree Lighting, Easter Egg Hunt, 9/11 Day of Service, and Vineyard Heritage Days

**“Public Comments”** is defined as time set aside for citizens to express their views for items not on the agenda. During a period designated for public comment, the mayor or chair may allot each speaker a maximum amount of time to present their comments, subject to extension by the mayor or by a majority vote of the council. Speakers offering duplicate comments may be limited. Because of the need for proper public notice, immediate action cannot be taken in the Council Meeting. The Chair of the meeting reserves the right to organize public comments by topic and may group speakers accordingly. ##### **5.1. 300 West Parking Updates Resolution 2026-03**

DISCUSSION AND ACTION: The Council will discuss existing no-parking and overnight parking restrictions along the full length of 300 West, including Vineyard Loop Road and South 300 West, and consideration of modifying or removing current signage to allow general on-street parking where capacity exists.

##### **5.2. Overnight Parking Permit Area at 100 West and 470 North (The Springs). Resolution 2026-02**

DISCUSSION AND ACTION: Discussion of the existing overnight parking permit and restricted parking designation at 100 West and 470 North in The Springs neighborhood, including consideration of modifying or removing the current permit area and associated signage. The council may act to adopt (or deny) the resolution.

## **RESOLUTION 2026-03**

### **A RESOLUTION MODIFYING PARKING REGULATIONS ON 300 WEST, VINEYARD LOOP ROAD, AND SOUTH 300 WEST WITHIN VINEYARD CITY**

**WHEREAS**, the Vineyard City Council has authority to regulate parking on public streets pursuant to Utah Code Title 10 and other applicable law; and

**WHEREAS**, the City Council adopted Resolution No. 2025-01 establishing a policy framework for parking regulations on public streets within Vineyard City; and

**WHEREAS**, Section E of Resolution No. 2025-01 expressly reserves to the City the authority to install or remove parking regulation signs on public streets when such action is determined to be in the best interest of the public; and

**WHEREAS**, the City Council has reviewed existing parking conditions along **300 West, Vineyard Loop Road, and South 300 West** and finds that removal of existing City-posted parking restrictions along these roadways is appropriate at this time;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF VINEYARD CITY, UTAH, AS FOLLOWS:**

1. Any existing City-posted no-parking, overnight parking, or similar parking restrictions are hereby removed from:
  - **300 West, including Vineyard Loop Road and South 300 West.**
2. City staff is directed to remove applicable parking regulation signage along the roadways identified above and to restore standard City parking regulations.
3. All other provisions of Resolution No. 2025-01 and the Vineyard City Code not inconsistent with this resolution shall remain in full force and effect.
4. This resolution shall take effect immediately upon adoption.

**RESOLUTION 2026-02**  
**A RESOLUTION MODIFYING OVERNIGHT PARKING PERMIT**  
**RESTRICTIONS ON 100 WEST AND 470 NORTH IN THE SPRINGS**  
**NEIGHBORHOOD OF VINEYARD CITY**

**WHEREAS**, the Vineyard City Council has authority to regulate parking on public streets pursuant to Utah law; and

**WHEREAS**, Resolution No. 2025-01 authorizes the City to establish, modify, or remove overnight parking permit restrictions on a neighborhood-by-neighborhood basis; and

**WHEREAS**, overnight parking permit restrictions have previously been applied to portions of **100 West and 470 North** in **The Springs** neighborhood; and

**WHEREAS**, the City Council has reviewed current conditions within the area and finds that removal of the existing overnight parking permit designation is appropriate at this time;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF VINEYARD CITY, UTAH, AS FOLLOWS:**

1. The overnight parking permit and restricted parking designation currently applied to **100 West and 470 North** in **The Springs** neighborhood is hereby removed.
2. City staff is directed to remove applicable overnight parking permit signage and revert the affected streets to standard City parking regulations.
3. All other provisions of Resolution No. 2025-01 and the Vineyard City Code not inconsistent with this resolution shall remain in full force and effect.
4. This resolution shall take effect immediately upon adoption.
