ORDINANCE 2026.XX

AN ORDINANCE AMENDING AND RESTATING TITLE 3, CHAPTER 1, SECTION 5 OF THE TOQUERVILLE CITY COCE CLARIFYING BUSINESS LICENSE RENEWAL DEADLINES AND ENFORCEMENT

RECITALS

WHEREAS, Toquerville City (the “City”) issues business licenses to regulate businesses operating within the City and ensure compliance with applicable laws; and

WHEREAS, the City requires annual renewal of business licenses to confirm continued compliance, maintain accurate records, and collect required fees; and

WHEREAS, establishing a clear renewal completion deadline promotes consistent enforcement and effective administration of the City’s business licensing program and ensures timely compliance with City Code.

ORDINANCE

NOW THEREFORE, be it ordained by the City Council of Toquerville City, State of Utah as follows:

1. AMENDMENT TO TITLE 3, CHAPTER 1, SECTION 5. Title 3 (Business and License Provisions), Chapter 1 (Business License Provisions), Section 5 (Application for License; Renewal) of the Toquerville City Code is hereby amended by adding a new subsection D (Renewal Completion Deadline) to read as follows:

D. Renewal Deadline: Any Business License for which the renewal form has not been fully completed and approved by March 1 of the applicable license year, including payment of all required fees, completion of all required inspections, and receipt of all required City approvals, shall be considered nonrenewable, and the applicant shall be required to submit a new Business License application and comply with Section 3-1-7(F) prior to lawfully engaging in business within the City.

2. REPEALER. All ordinances, resolutions and policies of the City, or parts thereof, inconsistent herewith, are hereby repealed, but only to the extent of such inconsistency and only for the period of time this Ordinance remains effective. This Repealer shall not be construed as reviving any law, order, resolution or ordinance or part thereof.

3. SEVERABILITY. Should any provision, clause or paragraph of this Ordinance or the application thereof to any person or circumstance be declared by a court of competent jurisdiction to be invalid, in whole or in part, such invalidity shall not affect the other provisions or applications of this Ordinance or the Toquerville City Code to which these amendments apply. The valid part of any provision, clause or paragraph of this Ordinance shall be given independence from the invalid provisions or applications and to this end the parts, sections and subsections of this Ordinance, together with the regulations contained therein, are hereby declared to be severable.

4. EFFECTIVENESS. This Ordinance shall become effective immediately upon approval by the City Council.
