2. Business/Action Items

2.1 Approval June 2025 Meeting Minutes: Mayor Tran handled the **approval of the June 2025 Meeting Minutes**. The motion was moved by **Mayor Maughan** and seconded by **Mayor Shepherd**. The motion passed with all in favor.

3. Presentations/Informational Items

3.1 3rd Quarter Transportation Projects: Jeff Oyler and Dave Mitchell presented. The presentation included the

results and recommendations from the Transportation Sub-Committee for the Third Quarter Grant Funding. • The total transportation asks identified this year were over \$37 million

- The committee was able to budget \$17-\$18 million
- The final list of approved projects totaled \$17,063,000
- The South Davis BRT (Bus Rapid Transit) project was highlighted as the first state program funded under this grant totaling \$72 million. The county committed over \$ 66 million in total funds to various projects
- The BRT project will result in increase frequency (from 30 to 15 minutes) and use all electric buses

Motion: To approve the recommendations was moved by Mayor Mark Shepherd and seconded by Mayor Rod Westbroek. The motion passed with all in favor.

3.2 City Responsibility for Weed Control: Rulon Fowers and Brandon Hunt presented. The presentation covered the control of noxious weeds, such as Phragmites, which are highly invasive, block water flow, and consume excessive water. It also covered the weed Russian olive.

- Brandon Hunt is the Davis County Weed Supervisor and is working to coordinate with a "City Weed Guy" in each municipality.
- The recommended treatment for Phragmites is to spray in the fall with an aquatic version of Roundup (Glyphosate), which must be done every year for at least four years.
- The Supervisor is able to issue tickets but prefers to work with landowners first. • The next step is a meeting between the Weed Supervisor, mayors, and city weed control personnel for demonstrations and assistance.

3.2.2 **Question:** What assistance is available to landowners for treatment?

3.2.3 **Answer-** Landowners can contact Brandon Hunt to see if they can use grant money to help offset the cost of eradication.

3.2.4 **Question:** What is the process for enforcement?

3.2.5 **Answer-** The County Weed Supervisor has the authority to issue tickets but chooses to work with landowners first.

3.3 Davis Links: Isa Perry (Health Strategy Manager, Davis County Health Department) • Davis Links is the county resource connection brand designed to help residents connect to essential, judgment-free resources through an efficient network.

- The resource directory features over 2,000 trusted programs for food, housing, healthcare, mental health, and more.
- The public website is DavisLinks.org (powered by FindHelp).
- The public site was launched in August. In its first six months (Jan-Jun), it had over 57,000 searches and 1,500 users.
- The team is currently working to "boost" local resources in search results.

3.4 Code Blue: Chanel Flores

- The Code Blue season officially started, with the required number of beds increasing to 30 (up from 16).
- The location for this year is Talia's at 22 East 200 South in Clearfield.

Key Changes:

- Three volunteers per shift are now needed.
- A new software sign-up system has been implemented.
 - A training night will be held at Talia's on Monday, November 3rd, at 6:00 PM.

- Searches will be conducted by the Sheriff's Office prior to entry (the Sheriff will be present during check-in/out).
