Council Member Theodore led the Pledge of Allegiance to the Flag of the United States of America.

1.1 Quorum Call—Roll Call Vote

Roll was called by the Council Clerk, showing that all Council members were present.

2. PUBLIC COMMENT

Public Comment will be limited to one hour

Council Member Theodore stated she knew many of the commenters in the room were attending to speak about the closure of the Tenth East Senior Center. She let everyone know the closure was currently on hold. She passed a clipboard around the room so interested constituents could sign up to be updated on the senior center.

Ms. Judy Miller spoke in opposition to the closure of the Tenth East Senior Center. She brought a petition with 58 signatures from the residents of Friendship Manor. She referred to the decision to close the center as a \$3 million mistake and a betrayal because of the money the Council had already spent renovating the center. Ms. Miller argued that the County's population of seniors over the age of 65 is increasing by about 13 percent a year and the County needs more services, not fewer. Isolation, lethargy, and exclusion are threats to the senior population, and having senior centers fights the health crisis.

Mr. Robert Hopkins spoke in opposition to the closure of the Tenth East Senior

Center. He and his wife have been utilizing the center for many years. During the renovation, he had to visit other centers, which were not convenient for them. He and his wife were extremely disappointed to learn that the Council had voted not to reopen the center. Mr. Hopkins was glad to know that the Council is now considering other options, but he was seeking absolute assurance that the center would reopen.

Ms. Cindy Cromer spoke in opposition to the closure of the Tenth East Senior Center. At the groundbreaking in November 1962, County Commissioner Buck Bradley stated the center was an excellent example of cooperation between Salt Lake City and Salt Lake County. In 1985, the City paid for more than half of the cost of an addition to the center. In 2018, representatives from the County sent patrons of the center a letter stating the City and the County would work closely with the public to discuss senior programming for the center. There no longer seemed to be collaboration between the City and the County, and Ms. Cromer wondered if the City felt just as blind-sighted as she did by the decision to close the center after the remodeling project had begun.

Ms. Mary Ann Wright spoke in opposition to the closure of the Tenth East Senior Center. As a taxpayer going back to 1978, she had been looking forward to being able to use the center someday. She explained the center offers classes to people who use wheelchairs or who are trying to stay physically fit. People are now being scattered to other places to get exercise that keeps them out of hospitals and care centers.

Ms. Tenille Taggart spoke in opposition to the closure of the four County-operated childcare centers and the closure of the Tenth East Senior Center. In her engagement with the community, she spoke to many people affected by these issues. She attended the Salt Lake County Democratic Party last week and met a high school student who told her these issues had been the liberal turning point for his high school. Many of the people affected would remember how they had been treated. Ms. Taggart reminded the Council that a philanthropist offered to cover the cost of the childcare centers.

Ms. Emily Long, LCSW, stated she previously worked in the District Attorney's Office's Survivor and Victim Support Services Division. While the office does great work, over 50 percent of the staff at the Survivor and Victim Support Services Division have left recently after having their employment terminated or being threatened with termination. The high turnover rate in that division has adversely affected victims. Ms. Long hoped the Council would approve the funds the District Attorney requested so that employees in the Survivor and Victim Support Services Division could feel safer and more valued. Since October of this year, 25 prosecutors have expressed a willingness to work with the employees who have grievances.

Ms. Jamaica Trinnaman spoke in opposition to the closure of the four County-operated childcare centers. She was able to send her son, Sebastian, to one of these centers, and it

was very beneficial for him. Statistically, quality early childhood programs lead to better social outcomes, such as stable employment and higher lifetime earnings, all of which reduce reliance on public assistance. Ms. Trinnaman asked the Council to reconsider how it invests in communities.

Mr. Erik Strindberg spoke in opposition to the closure of the Tenth East Senior Center. His mother used the facility until she died, and he also used it. Many seniors have limited mobility and are financially struggling. The center offers them the resources they need.

Ms. Marge Pett spoke in opposition to the closure of the Tenth East Senior Center. When she initially learned of the renovation, she was agreeable to it because just as aging is a human experience, it is also a reality for buildings. However, she was disappointed to learn of the Council's decision to close the center. While the building is County property, the grounds will revert to the City if the center is closed. She urged the Council to reconsider its vote. Like childcare, she felt this should not be a partisan issue, but a community issue. Taxpayers have supported this valued countywide health resource for many years.

Mr. Joel Briscoe spoke in opposition to the closure of the Tenth East Senior Center. He stated he spent many years in public service, and he understood the sacrifices made by the Council members. That said, he had never seen a cure cost more than a prevention. Salt Lake County has, for a long time, been known as a place where things such as childcare or senior care get done. He encouraged the Council to work the issues out in a nonpartisan manner. Many Americans are becoming increasingly frustrated with politicians, and they are tired of things not getting done.

Ms. Esther Hunter, Chair, East Central Community Council, spoke in opposition to the closure of the Tenth East Senior Center. She stated aging is a beautiful and natural process that does not necessarily need to be linked to decline. In Japan, the elderly are seen as wisdom keepers and national treasures. She encouraged the Council to adopt the same core concept by investing in seniors and viewing them not as passive recipients of services, but active contributors whose experience, wisdom, and energy strengthen the community.

Ms. Stefanie Wright spoke in opposition to the closure of the four County-operated childcare centers. Her daughter did not want to see the center she attends close. She told the Council it was elected to safeguard the community and make the best decisions on its behalf, but that was not happening. Constituents have shown up as a community. They have organized, emailed, called, spoken at meetings, done their own research, and spoken with the media. Despite this, the Council did not seem to take them seriously. Trust had been eroded. A few weeks ago, the Granite School District

decided to delay its vote to close schools after listening to public concern. Ms. Wright stated the constituents of the five Council members who voted to close the childcare centers would not forget how they had been treated.

Ms. Hazel Roehrig spoke in opposition to the closure of the Tenth East Senior Center. She stated progressiveness is supporting the development of stable communities and resources within cities, not replacing beneficial programs with luxury condominiums and housing that is unaffordable. When lifelong taxpayers see taxes go up as social programs are eliminated, they fail to see the benefit. A vote to save the center would signal a commitment to the people being served.

Mr. Jefferson Curtis spoke in opposition to the closure of the four County-operated childcare centers. He stated closing the program would force many people, mostly women, out of the workforce and into poverty. Middle income families are struggling to make ends meet, and many of the Council members do not seem to care. The conduct of hiding the initial vote, refusing to engage with colleagues and the mayor, and even turning down a philanthropic offer had been unethical. Families have had the rug pulled from underneath them and this would be the legacy of the Council members who voted to close the centers.

Mr. David Oman spoke in opposition to the closure of the Tenth East Senior Center. He has been involved in civic issues in the County for decades. Over 600 constituents attend the center. This is the second senior center the County had closed, and 330,000 seniors were watching the issue closely.

Ms. Megan Harthun spoke in opposition to the closure of the four County-operated childcare centers. She pleaded with the Council to reverse its decision. Children need stability and safety, but despite promises made, nobody on the Council had provided anything useful in terms of resources or help. Her children no longer had a place to go after school.

Mr. Brent Walker spoke in opposition to the closure of the Tenth East Senior Center. He had been attending senior centers three to five times a week. He thanked Council Members Harrison and Johnson for volunteering at the centers and serving meals. He did not understand the decision to close the Tenth East Senior Center after all the renovations that had been done.

Mr. Kent Singleton spoke in opposition to the closure of the Tenth East Senior Center. He argued that seniors need services more than ever, but while the need is growing, services are shrinking. He asked the Council not to quietly dismantle the Aging and Adult Services Division.

Ms. Malanie Call spoke in opposition to the closure of the four County-operated childcare centers. She stated she is a stay-at-home mom because she was pushed out of the workforce. This type of program would have been a lifeline for her. She understood saving the centers would be costly, but the return on investment would be \$4 to \$9 million more than the cost.

Ms. Jordyn Smith spoke in opposition to the closure of the four County-operated childcare centers. She stated she did not have the luxury of living in a one-income household. For months, she had been struggling to make up for what had been lost, even though she holds an MBA degree. She was not asking for a handout; just for help.

Ms. Lucille Hesse spoke in opposition to the closure of the Tenth East Senior Center. She had been looking forward to being able to attend the center before the renovations started. There are continuous problems in that area with college students partying, petty theft, noise, etc. Seniors never know when health issues are going to strike. The senior center would have been a lifeline for her. People struggle when they age, and nobody is exempt.

Mr. Jacob Nielsen spoke about the permitting process in relation to the Salt Lake County noise ordinance. He and his crew must often work at night and the process for getting a permit is cumbersome. He asked for guidance in navigating the process.

Council Member Harrison referred Mr. Nielsen to Dorothy Adams, Director, Salt Lake County Health Department.

Mr. Aydan Williams spoke in opposition to the closure of the four County-operated childcare centers. Roughly 300 families use these services. Abandoning them would be too much. He asked for equity, which means providing for people based on need rather than equality.

Mr. Mackenzie Miller spoke in opposition to the closure of the four County-operated childcare centers. He was raised by a single father who stayed in the Navy because he had no other options. Mr. Miller stated he knew what it was like to struggle in life, and he could usually tell when people had struggled and when they had not. If these childcare centers closed, it would send his family back into poverty. He offered to work diligently with the Council to find ways to keep the centers open.

Ms. Autumn Marshall spoke in opposition to the closure of the four County-operated childcare centers. She stated she had observed that the Republicans on the Council had failed to empathize with 271 children and their parents. While Ms. Marshall did not have children herself, she had experience working in childcare.

Ms. Alaina Benson spoke in opposition to the closure of the four County-operated childcare centers and the Tenth East Senior Center. As a survivor of domestic violence, she had to send her children to childcare after leaving a toxic domestic situation. Her former spouse had not provided child support in five years, and without childcare, she would have had to rely on public assistance. Every day she speaks to seniors who are alone and in need of food assistance and help with transportation. She urged the Council to reconsider its decisions.

Ms. Jessica Earl spoke in opposition to the closure of the four County-operated childcare centers. She emphasized to the Council that it was not too late to change the vote, especially for something so crucial to the community.

Ms. Stephanie Gardner spoke in opposition to the closure of the four County-operated childcare centers. Even those who are most concerned about how their tax dollars are being spent feel there must be better options than shutting down vital resources. While the budget is complex, childcare is not a line-item to be easily cut. Members of the community now question the Council's true intentions. She urged the Council to find better solutions.

Mr. Luke Maynes spoke in opposition to the closure of the four County-operated childcare centers and the Tenth East Senior Center. When he was a child, his mother died. His father had to work three jobs to support the family. Fortunately, his family had support. However, he still had enough empathy to understand that not everyone had the resources he did. The measure of a civilization is how it provides for its most vulnerable. These centers provide community, which has exponential benefits.

Ms. Jordan Blaser spoke in opposition to the closure of the four County-operated childcare centers. Her family was able to prioritize her being a stay-at-home mom for ten years, but things had gotten to a point where it was simply no longer feasible. She begged the Council for more time to find ways to save the childcare centers. She had no doubt that the group of parents affected could help with the effort.

Ms. Liz Oates spoke in opposition to the closure of the four County-operated childcare centers and the closure of the Tenth East Senior Center. Everything is getting more expensive. The County childcare centers are well-run, and the children enrolled in them are thriving. She stated many members of the community she has spoken with wanted these services to continue to be funded, even though they did not utilize the services themselves.

RESOLUTION APPROVING AN INTERLOCAL COOPERATION AGREEMENT TO FUND THE INTEGRATION OF THE SALT LAKE VALLEY EMERGENCY COMMUNICATIONS CENTER'S SYSTEM

THE LEGISLATIVE BODY OF SALT LAKE COUNTY RESOLVES AS FOLLOWS:

RECITALS

Whereas, the County, through the Salt Lake County District Attorney's Office, utilizes an electronic case management and filing system, eProsecutor, to, inter alia, obtain records from law enforcement, to store and share records with defense attorneys and courts, and to file pleadings and other papers in district court; and

Whereas, the Salt Lake Valley Emergency Communications Center (SLVECC) is a joint enterprise between Murray City, Salt Lake County, South Jordan City, South Salt Lake City, West Jordan City, and West Valley City which handles emergency communications and other services, including 911 calls and police, fire and medical dispatching; and Whereas, SLVECC currently uses an electronic system, Versaterm RMS, which is not compatible with eProsecutor and which requires time-consuming and redundant steps that are error prone, to upload needed offense reports to eProsecutor; and Whereas, Versaterm has identified a one-way interface that will support fast, simple and error-free transfer of old and new offense reports to eProsecutor; and

Whereas, the Salt Lake County District Attorney's Office believes the interface will benefit the County, SLVECC and law enforcement agencies within Salt Lake County; and

Whereas, there is a one-time fee to install and implement the interface and a yearly subscription cost thereafter, and the County has proposed that it cover the one-time cost and SLVECC cover the costs for each annual subscription; and

Whereas, the Interlocal Cooperation Act, Title 11, Chapter 13, Utah Code, permits local governmental agencies to enter into agreements to share resources to more efficiently provide services for the community;

Mr. David Delquadro stated the Council recently acted, during the budget deliberations, to reduce the structural cost of the budget by \$12.4 million. That savings would be applied to the proposed tax increase of \$48.9 million, reducing it to \$36.5 million. That amount would be included in the budget resolution for the vote later this evening. There would also be a few technical changes. He asked if there were any items the Council would like to revisit, as it would be preferential to do so now rather than at the 6:00 PM meeting.

Council Member Stringham stated the Council had been getting a lot of questions over the pre-Covid Health Department versus the post-Covid Health Department. She wanted to establish legislative intent to have the Council take a closer look at the budget over the next year and make sure the funds and job positions from the old program were cleaned off from the books.

Ms. Erin Litvack, Deputy Mayor of County Services, stated she had no objection to going back and looking at this, as much of the time-limited funding the County received during Covid had, indeed, since been rolled off. There might still be one outstanding grant. She was never opposed to educating the Council on the Health Department's budget.

Council Member Stringham stated since the Mayor's Office was agreeable to doing this, she did not need to establish legislative intent.

Council Member Stringham stated she had also received a lot of feedback from people who believed the Mayor's budget had not been cut enough. She asked for the record to reflect that since her time on the Council, the Mayor had either lost or voluntarily given
