1. SWEARING IN NEWLY ELECTED MAYOR AND COUNCILMEMBERS:

The Mayor and Councilmembers took their seats at the rostrum.

2. CALL TO ORDER:

Mayor Thompson offered Reverence and led the Pledge of Allegiance to begin the meeting.

3. BUSINESS:

Mayor Thompson went over the Open and Public Meetings Act and Privacy training that needs to be completed online by the end of January.

It was noted that the Mayor and Councilmembers were given the Conflict of Interest and Ethical Behavior policies with instructions to read the policy and return the forms stating that they were read and understood along with any declaration of conflict of interest to Deputy Clerk Jones.

The annual dog clinic has been scheduled for February 7, 2026, at 10 am to noon in the roads building. Any councilmembers that can be there to help would be appreciated.

MAYOR THOMPSON

Public Comment:

This was a period for people to let the councilmembers know what was on the public’s mind and what they want them to work on. Councilmember Petersen stated that anyone can sign up on the Public Notice Website to get an email of the next agenda when it is posted.

Curtis Godfrey – Mr. Godfrey thanked the mayor and councilmembers for running and serving the town. He said that in small towns you don’t run for a term, you take your turn. He suggested that, instead of saving public comment time until the end of the meeting, the council try to have a short public comment after each item on the agenda. That way people wouldn’t have to stay for the whole meeting if they didn’t want to. He restated his support and appreciation for the newly elected council.
