



# Jeff Snider's Answers to City Council Application Questions

## 1. What are your qualifications to be appointed to the City Council?

My qualifications for City Council center on leadership, fiscal responsibility, and a proven track record of serving people well. These can be grouped into five categories:

### a. Executive and financial leadership

I was the second employee at a startup called DigiCert, which is now a multi-billion dollar company based here in Utah. I spent about a decade at DigiCert, helping to grow it from a tiny startup to the point where the founders sold it for a couple hundred million dollars. As an executive vice president through that stage of growth, I had a hand in many aspects of the business and visibility into nearly the entire thing. The experiences I had at DigiCert have helped shape my views of responsible spending, motivated but measured growth, and innovation, all of which I believe translate directly to city government. Much of this work required collaborating across departments, weighing competing priorities, and making decisions with long-term consequences.

### b. People-first management and service

Beyond the financial side, the thing that made DigiCert so special during my time there was our focus on our employees and on our customers. DigiCert made its name on elite customer service, with virtually every decision made from the mindset of "how will this make things easier for our customers?" That approach allowed us to win customers from much larger, less responsive companies. On the employee side, I came up with an idea for our benefits package that gave employees an extra week off and a vacation stipend, provided that they used it to go somewhere really cool. Several other technology companies here in Utah have since adopted similar concepts into their benefits packages.

I believe a city council should have a primary focus of taking good care of the city's residents, and I think my experiences taking care of our employees and our customers give me valuable insight into that.

### c. Communication and public engagement

Since DigiCert, I've owned, edited, and written for a baseball website and hosted over 2,000 episodes of baseball-related podcasts. These side projects have allowed me to hone my communication skills, both written and verbal, and helped me become quite comfortable with talking to people publicly and privately, explaining complex issues, answering questions clearly, and engaging respectfully with people who disagree with me.

### d. Local operational experience (assisted living)

I currently work as the Dining Services Director at an assisted-living home in Lindon, and this role has allowed me to use my communication and management skills as I manage my team of about 20 people who are charged with providing nutritious and delicious meals for nearly 100 residents every single day. 


