

**HUNTINGTON CITY  
RESOLUTION 4-2026  
A RESOLUTION AMENDING THE 2025-2026 FISCAL YEAR  
FEE SCHEDULE FOR HUNTINGTON CITY**

WHEREAS, Huntington City ("**Huntington**") is a municipality and political subdivision of the state of Utah; and

WHEREAS, the Huntington City Council ("**Council**") adopted a fee schedule FOR THE 2025-2026 FISCAL YEAR pursuant to Section 7-5-3 of the Huntington Municipal Code, which states that the "city council shall from time to time by resolution adjust fees at which shall be charged for the various services to be provided" and "shall establish by resolution the fees at which shall be charged;" and

WHEREAS, Huntington contracts with the Castle Valley Special Service District ("**CVSSD**") whereby CVSSD provides water and sewer services and imposes rates for culinary, secondary, outside of district, and sewer through charging fees (the "**Rates**"); and

WHEREAS, the CVSSD Board of Trustees approved the attached fee schedule to increase the rates for water and sewer to Huntington during the 2025-2026 fiscal year; and

WHEREAS, the Council sets the rate schedule for water and sewer within the proposed 2025-2026 fee schedule pursuant to Utah Code Subsection §10-3-717(1)(a); and

WHEREAS, the Council desires to repeal Huntington's fee schedule on water and sewer rates in response to the increased rates for same services as approved by the CVSSD to avoid double charging; and

WHEREAS, the Council desires to adopt the attached fee schedule for the 2025-2026 Fiscal year.

NOW THEREFORE, BE IT RESOLVED by the Huntington City Council effective immediately that:

1. The attached fee schedule is adopted as the Huntington fee schedule for the 2025-2026 fiscal year, subject to the fee schedule set by CVSSD.
2. Huntington's staff are authorized and directed to file this resolution and the attached fee schedule with the Huntington City Recorder.

BE IT FURTHER RESOLVED, this resolution shall become effective January 1, 2026 and repeals and replaces any previous fees.
