2. Consideration of appointing members to the Board of Health – Dustin Grabau

**Summary:** The Board of Health is a state mandated board with responsibilities to oversee activities of the Health Department. Two seats of the Board of Health expire every year. Following a public posting of the vacancies, the County Manager's Office received two applications for this seat and recommends the following:

- Janet Carson and Tod Berg be appointed to the Board of Health for terms expiring at the end of 2028.

### **Council Items**

1. Discussion and Consideration of Council Subcommittee Assignments – Richard Breitenbeker

**Summary:** Improvements to tracking various legislative and advisory bodies in 2024 led to a more thorough update to council assignments in 2025. Subcommittee assignments are reviewed each year in order to keep administrative efforts and legislative efforts aligned. Council members expressed desires in 2025 to simplify and improve subcommittees. Accordingly, this year's review of subcommittee assignments proposes condensing them by broadening their scope.
