Council Items

1. Discussion and direction of the Jordanelle Ridge Conservation Easement
– Dustin Grabau

Summary: The County has been working with Heber City and the property owners of Jordanelle Ridge located on the east side of Highway 40 and Highway 32 in Heber City. In the fourth quarter of 2025, the county provided direction to staff on whether the county should continue to pursue a full conservation easement on the Jordanelle Ridge property.

2. Discussion and direction of SITLA property development progress – Dustin Grabau

Summary: Wasatch County has been working with the property owner's representatives on a Legislative Development Agreement for the potential development of the 720 Acres of State Institutional Trust Land (SITLA) property located north of Littlepole Road. The council gave general direction that the target density was 144 units. Since then, the county has exchanged drafts of the development agreement. Additionally, the property owner's representatives are working with an adjacent property owner on a potential preliminary municipality that could have the potential to impact this project in addition to the rest of the county. Direction on the current status of the property development, including the potential for a preliminary municipality.

3. Heber Valley EIS Update – Craig Hancock

Summary: The Utah Department of Transportation has provided updates to the Wasatch County Council on a monthly basis as updates to the Heber Valley Corridor project has progressed. On January 7th, 2026, the Draft Environmental Impact Statement was released to the public, and Update the Wasatch County Council on the released Draft Environmental Impact Statement.
