Annual Conflict of Interest Disclosure Form

The following disclosures are required to be made annually by all officers of Compass Point Public Infrastructure District No. 1-8 pursuant to Utah Code Annotated 17-16a-6, Utah Code Annotated 17-16a-7, and Utah Code Annotated 17-16a-8. If additional space is needed, please use a separate sheet of paper. Per statute, the information provided shall be kept on file with the Board of Trustees and may be subject to disclosure to the public.

*Note: There is no case law or statutory guidance as to what constitutes a business entity "subject to regulation of the County." A business which is simply issued a business license by the County may or may not be deemed by a court, administrative agency, an auditor, or member of the public to be an entity regulated by the County. Businesses regulated by interlocal agencies of which the County is a member may or may not be deemed to be a business regulated by the County (i.e., a restaurant subject to regulations imposed by an interlocal agency).

A business entity which requires a conditional use permit to operate may more likely be deemed to be a business entity regulated by the public infrastructure districts than a business that simply receives a business license from the County.
