Mayor Catlin called the meeting to order at 6:00 p.m. Councilwoman Chamberlain led the Pledge of Allegiance. Invocation was led by Councilwoman Preslar.

1. Ash Creek Special Services District Representative – Matt Goodrich
Matt reported on the ribbon cutting for the new treatment plant in Confluence Park.
2. Hurricane Valley Fire District Representative – Robert Hooper
Robert reported that the Fire District responded to only six calls in Toquerville during the month of December.
3. Assistant City Manager – Darrin LeFevre



Darrin provided updates on the parkway regarding signage, moving the TDS wire across the south cut, and the final steps for finishing up the parkway. Darrin also reported on the Chief Toquer Reservoir dam, Boulder Ridge, and IME Automations.

4. City Manager – Ben Billingsley

Ben reported on the last days of leaf pickup for the community and the Fiscal Year 2024-2025 financial report. Ben noted that the submission deadline for the City's financial report has passed and the financial auditor is waiting for a response from the State Auditor's Office regarding the Component Unit Reporting of Public Infrastructure Districts before issuing financial statements for Fiscal Year 2024-2025. Councilman Sands requested public works address the storm drains while doing the last leaf pickup, also addressing cleaning up trees.

Hannah Boling introduced herself to the Council and went over the city's water meters, detailing how they work and connect to the EyeOnWater app, which allows residents to monitor their water usage. EyeOnWater utilizes Yoppify, a communication software, to send leak alerts to residents. Hannah also discussed the city's leak relief program and its operation. She and Ben both answered questions from the Council regarding the leak relief program, EyeOnWater, and Yoppify.

Ben presented a slideshow on the water policy, providing an overview of its function. He shared statistics from the previous year, highlighting how many residents participated and paid fees, and compared how many benefited from the program versus those who did not. The council discussed the water policy, the rate increases for secondary water, and TSWS connections.

Councilman Olsen made a motion to approve Resolution 2026.XX – a resolution eliminating the seasonal expanded culinary water base rate for users without secondary irrigation service. 
The Council moved out of a closed session at 9:59 pm.

H. ADJOURN:


Mayor Catlin adjourned the meeting at 9:59 pm.
