LEGISLATIVE INITIATIVES



H.B. 87 Animal Crime Victim Amendments

Require courts to determine disposition of animals held in cruelty cases at the first scheduled hearing. Does not require owner attendance. Addresses cost of care.

Benefits

- Clarifying provisions related to the release & forfeiture of animals reducing unnecessary hold times
- Prioritizes animal welfare in abusive and/or exploitive cases.

S.B. 102 Animal Control First Responder Amendments

Currently the law only includes animal control officers that are part of a police or sheriff agency. Requesting change to include all municipal animal control employees that meet the first responder requirements.

Benefits

- Strengthens workforce readiness by extending access to first responder mental health and substance use resources
- Improves coordination within emergency and public safety systems, benefiting dispatchers, responders, and the public
