
3. BUSINESS MANAGER REPORT

i. Updates from 3rd party review


The review is expected to be completed by next's month's meeting.

- Final Decision: Consensus to adopt the revised policy, emphasizing practicality and safety.



a. Principal's report


i. School Climate Survey Teacher Results
