**Upcoming Activities and Events**

Commissioner Killian explained that there are equine restrictions and the open riding for the County has closed until the 1<sup>st</sup> of December. Duchesne City is having its light parade on December 6<sup>th</sup>. It will be off Highway 40 by the Event Center starting at 5:00 pm. The Enchanted Forest was last week in Roosevelt and went well. They raised over \$288,700 for charity. Roosevelt and Tabiona are hosting a tree lighting event.

**Other Business**

Duchesne City Council Member Jenny Adams asked for an update on the railroad. Commissioner Miles said it won in the Supreme Court and is now awaiting a decision from the Surface Transportation Board. The Geotech drilling permit was reinstated. The engineering is moving forward, and hopefully, the construction will start in 2026. There is a high chance of Congressional approval. Sanpete County has joined the Seven County Infrastructure Coalition; they plan to rename it. The private activities bonds are approved. The parties discussed NEPA

and the permitting process, as well as the SPEED Act, for which the Commissioners recently approved a letter of support.


**Adjournment**
