## **Procedures for Filling a Vacancy on the Hurricane City Council at a Special City Council Meeting on January 29, 2026**

1. The meeting will be held at the Hurricane City Council Chambers on January 29, 2026 and will begin at 6 pm.

2. After any preliminary business, the Council will begin the process of interviewing the eleven candidates that submitted an application to fill the vacancy. The order of the candidates' interviews will be based on the 2024-2025 Master Ballot Position List published by the Utah Office of the Lieutenant Governor. Interviews for each candidate will be limited to 15 minutes, and the City Recorder will time each interview with a timer in Council Chambers that is visible to the Council and the candidate.

3. All candidates are welcome to attend the opening of the meeting at 6 pm and any preliminary business items. However, during the interviews, only the candidate being interviewed is permitted in the room. Candidates may wait in the foyer outside the Council Chambers until they are invited in. The public is permitted in the Council Chambers for the duration of the meeting. At the conclusion of the final interview, all candidates will be invited into Council Chambers for the selection of the candidate to fill the vacancy.

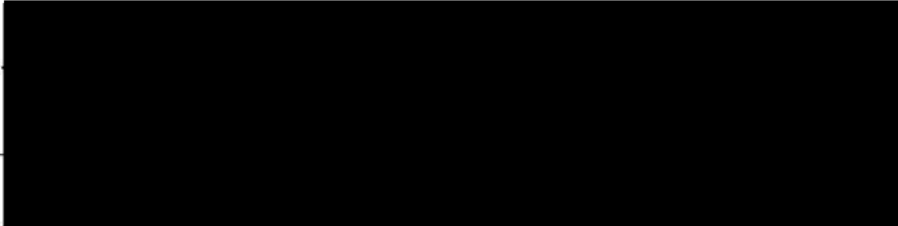

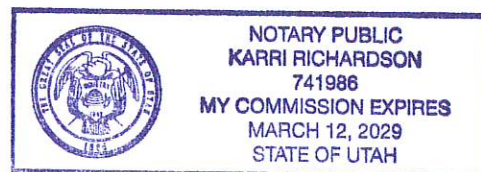

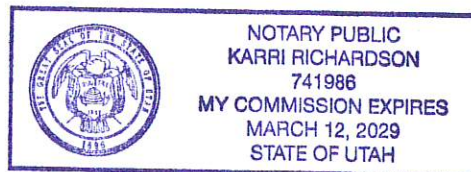

One of my earliest childhood memories was watching election returns when Ronald Reagan was elected President of the United States. My parents were both ecstatic and extremely optimistic that President Reagan had prevailed. I vividly remember having been fascinated with their explanation of the electoral college and the impact on the election. Since then, I have always been passionate and excited about government, elections, political issues and community service. I have spent countless hours learning about civic issues and actively encouraging responsible, common sense policies and decisions, especially on the local level.

My first introduction into the political world was in college when I wrote for the student newspaper at the University of Utah *The Daily Utah Chronicle*. I was assigned to report on what happened at the student council meetings and to cover that year's Utah State Attorney General race where I interviewed candidate Scott Burns and (as a journalist) spent considerable time with his campaign. These were formative experiences, adding to my keen interest in political and civic issues.

During the past 30 years, I have been able to increase my political involvement. I was elected vice chair for my precinct at the Washington County GOP caucuses in March of 2022, and I interacted and interviewed many candidates for county and state offices. I also served as a county and state delegate that year. Two years later, I was elected chair for Hurricane Precinct 13, and I currently serve in that capacity. I also was again elected as a county and state delegate. The constituents in my precinct received regular communication from me regarding meetings, elections, and party initiatives. I took my responsibility to vet candidates very seriously and I enthusiastically attended and researched as many candidate events as possible. I reported back to my precinct on my findings and listened to their feedback. When it came time for me to vote during county and state conventions, I believe I did so responsibly, according to the trust my precinct placed in me. Many constituents commented that they appreciated the consistent communication received from me. I have thoroughly enjoyed volunteering for these civic responsibilities.

In 2023, I made the decision to run for Hurricane City Council. I had many people whom I respected encourage me to run for office. It was a wonderful experience. I responded to citizen and media requests. I was open about my views. I listened to hours of city council meetings and zoning and planning commission meetings to better understand how city government works. I participated in all debates and engaged with citizens. There were three open positions that year. I came in third place during the primary election which allowed me to advance to the general election where I came in fourth place, losing by just 46 votes. I was the first place winner in 5 of 12 Hurricane precincts that year. I felt that my candidacy received broad support and many constituents would have liked seeing me serve on the Hurricane City Council.

Last February, Mayor Billings reached out to me and asked if I would be willing to serve on Hurricane City's Zoning and Planning Commission. I enthusiastically accepted. In following up with Hurricane residents after my election defeat, I received very positive comments and many encouraged me to try again in the future. Some suggested I would be a stronger candidate if I gained more experience working in a city or civic volunteer capacity. That is not the only reason

I agreed to serve on the commission, but it has allowed me to gain that valuable experience. My service on the zoning and planning commission has substantially increased my knowledge of zoning laws, legislative and administrative actions, infrastructure, land use, safety, thoughtful and measured growth and demonstrated how such decisions align with the general plan of our city. My first foray into this volunteer government service has been positive, providing me confidence, experience, and a voting record that reflects my priorities for the city.

Through my service on the zoning and planning commission, I have come to recognize that, at times, our community was growing faster than our infrastructure and resources could support. I am encouraged that the Commission and Council are taking a more measured and responsible approach to growth. Hurricane City will continue to grow, and it is essential that we ensure infrastructure is in place and that residents benefit through increased business and job opportunities, housing options for all income levels, and higher-quality residential and retail development.

We must ensure a sustainable water supply, negotiate affordable energy rates, and maintain a safe, welcoming community. As the "Gateway to Zion National Park," we should attract tourism dollars while providing ample recreational and family-friendly opportunities, not just for tourists, but ideally for our own families. Our children, and especially our teens, deserve a community where they will want to stay, raise their own families, and thrive.

My political beliefs definitely lean conservative. I firmly support individual rights and that our local, state, and national government policies should create opportunities for every individual to succeed with hard work, and enjoy life; that city government should reflect the values of its citizens, and be responsive to concerns. I believe city government officials and staff should be transparent, ethical, and constantly communicating with constituents and that as fiduciaries, city officials must carefully, prudently, and judiciously spend and account for its tax dollars.

If appointed, I welcome this opportunity to serve the city of Hurricane. Do I have time to devote to the city council? Yes! As a speech/language pathologist for the school district, I have a straightforward, predictable and patterned schedule which enables me to commit to late afternoon, evening, and weekend meetings and needs. My family also enthusiastically supports me in this endeavor. I am willing and able to make time for service on the city council.



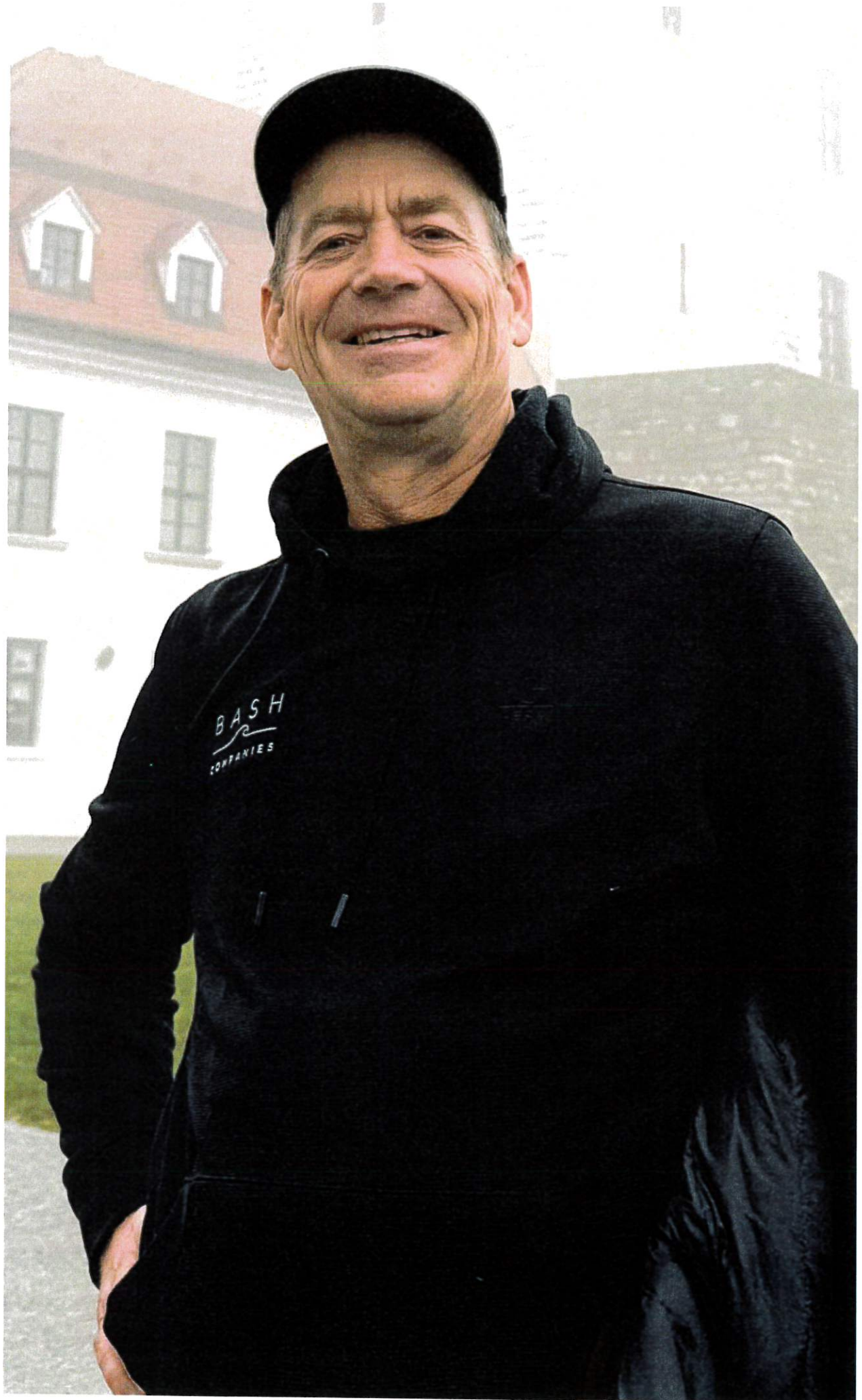

**Bringing a complex systems perspective to our city council.**

I'm educated and experienced in complex system/product development—products like commercial aircraft, complex manufacturing systems, and high-tech electronics development—applied for 30+ years in places like Boeing, P&G, CAT, Toyota, GE, Texas Instruments and others. Complex systems engineering's goal is to identify and correct complex problems before they get costly/intractable. .

In early 2019, Mayor Bramall asked me to get involved, bringing that engineering perspective to the planning commission. That involvement included volunteering to work with the planning department and a consultant to develop the current general plan. Now that the strategy is in place, we need to execute against the plan—much like any product development effort. Our growing city with its growth problems is a complex system on the same level as many of the products I've worked on.

As I've participated in the City Planning Commission sending recommendations to the City Council the problems look familiar, only the industry vs city context is different. Some examples:


- The hour's long discussions in city council on liability associated with a dam at Southern Shores
- Maverick choking access to commercial land on SR-9 between 3400 W and 3700 W
- Growing 1100 W traffic problems as development builds south
- Power line encroachment on 600 N Peregrine Point Phase 3

These types of problems are easy to see after (like this "column of shame" at my engineering college), but difficult to see before, thus my training in the discipline of systems engineering. We have a complex problem of growth in Hurricane and need to apply system thinking principals to prevent these problems in the future

As planning commission member/chair I see the issue and have been working the affordable housing issue (see attached unaffordable housing root cause analysis):

- The recent flag-lot code changes to simplify building infill housing
- Working with Councilman Thomas on R-4 zoning community acceptance

I propose as a Hurricane City Council member I can bring a systems perspective to our growing problems. We have a unique opportunity to get this right now vs finding out later when it gets expensive. The General Plan provides the strategy; successful execution will require complex systems thinking. I can provide that perspective to the city council to help guide us in fulfilling the general plan direction. I live here. I hope to apply that experience to where I live.

As most of you are aware, I have served two, non-consecutive terms on the Hurricane City Council. My first term was a tremendous learning experience as well as one of accomplishments. During my first term in office, I drafted and proposed the ordinance for Residential Hosting in our city. We were among the first cities in Utah to do so. Most cities were reluctant to craft an ordinance and were telling people "No". The state finally came down and told cities that they can't forbid something that is not specifically forbidden in their ordinances. Therefore, it was required that all cities draft an ordinance of some type. I feel that our ordinance was well drafted and led the way for a quality ordinance that was followed by other cities.

I am also the one who crafted the original Vacation Rental ordinance that allowed for whole home vacation rentals. That ordinance has not worked out quite as well as we had hoped and therefore, I was also one of the ones who led the charge to restrict that ordinance from expanding and to actually reduce its use through attrition. I also pushed for our removing the vacation rental used from commercial zones in town since much of our commercial was being used up for that purpose.

I am also the person who drafted the ordinance for allowing single family homes in residential zones to be able to rent out spaces like basements and bonus room type areas as long term rental spaces. Before I was elected, it was illegal to long-term rent any part of any home in town unless it was zoned for multi-housing.

During those first four years I learned a lot, some of which was from making votes that I regretted. Sometimes I cast poor votes because of pressure from others, while other times it's because of my own ignorance on the issue before me. The value of time and experience on the council helps to prevent those kinds of poor votes.

I also learned a lot about pressure from the public and how to handle that. That kind of pressure is tricky. It is so important to be in tune with the public and their needs and desires. It's also important to be able to distinguish between true public opinion and the opinion of only a few loud souls who don't represent the public at large.

I have proven my willingness to spend the time necessary to vet the issues. I believe that I am well informed and have the ability to vote with knowledge, wisdom and discernment on the very difficult issues that are ahead of the city. I have already proven myself willing and able to vote independently of pressures both from family and peers and to vote based on reasoning and independent study.

I am keenly aware of the myriad of difficult challenges that we will face in the coming two years. I would not need to be brought "up to speed" on the issues at hand. I would be able to hit the ground running. Indeed, I feel that I am, by far, the most qualified and prepared individual that you have to choose from to fill this position.

I understand that many of those who have put their names in for this position are skilled, knowledgeable and fully capable of filling this position. I am also sure that any of them would do a fine job, should you choose to vote for them, instead of me. However, given the fact that two of the current council are experienced and two are brand new, I believe that I would be the better choice because I think it is wise to have three of the five council members be ones with experience and not rely on three new individuals to make these difficult upcoming votes.

I don't need this position for any self gratification or affirmation of my self worth. I'm not sure that I even want to do it. However, I feel compelled to apply because of my unique experience over all of the others who have chosen to apply.

## **MEMORANDUM**

RE: Procedure to Fill the City Council Seat Vacated When Clark Fawcett Was Elected As Mayor

---

### **I. Notice and Timing Procedures.**

A vacancy on the Hurricane City Council occurred on January 5, 2026, when Councilman Clark Fawcett was sworn in as the newly elected Hurricane City Mayor. The City Council is required to fill the vacancy within 30 calendar days of the vacancy, which puts the deadline to fill the vacancy on February 4, 2026.<sup>1</sup> The City must give public notice of the vacancy at least 14 calendar days before the day on which the Council will meet to fill the vacancy.<sup>2</sup> On January 6, 2026, the City gave public notice of the Special City Council as required by the Utah Code. The Council meeting scheduled for January 29, 2026 to fill the vacancy satisfies the statutory timing requirements.

### **II. Interviewing Candidates.**

Candidates must be interviewed by the Council in an open meeting.<sup>3</sup> The Council may, consistent with the Utah Code, adopt procedures governing the appointment, interview, and voting process for filling the vacancy.<sup>4</sup>

### **III. Appointment Procedures, including Tiebreaking Procedures.**

After interviewing each candidate, the City Council takes an initial vote to fill the vacancy.<sup>5</sup> If a candidate receives a majority vote of the City Council on the initial vote, the candidate is appointed to the position. Because Hurricane City operates under the six-member council form of government, the mayor is specifically authorized to vote to break a tie “on each matter for which there is a tie vote of the other council members present at a council meeting, including a tie vote to fill a mid-term vacancy under Section 20A-1-510.”<sup>6</sup> The mayor votes to break ties, so the coin toss tiebreaking provisions of Section 510 will only apply if the mayor is not present or if the mayor’s tiebreaking vote does not resolve a tie. Therefore, on the initial vote, if two councilmembers vote for one candidate and two councilmembers vote for another,

the mayor casts a vote to break the tie and the candidate receiving three or more votes is appointed.

If the initial vote does not result in a majority vote for a candidate, the procedures in Utah Code Sections 20A-1-510 and 10-3b-302 will apply, as detailed below.

When the initial vote does not result in a majority vote for a candidate, and also results in a tie for second place, the candidates tied for second place shall be reduced to one by a tiebreaking vote of the mayor and, if necessary, a coin toss. Then, there is another vote between the candidate that received the most votes in the initial vote and the candidate that prevailed in the second-place tie breaking procedure.<sup>7</sup>

When the initial vote does not result in a majority vote for a candidate, but results in a tie among three or more candidates for first place, the candidates tied for first place shall be reduced to two by a tiebreaking vote of the mayor and, if necessary, a coin toss. Then, a second vote shall be held between the two candidates that prevailed in the tie breaking procedure.

#### **IV. Example Scenarios.**

1. Example 1: With four council members holding council seats, three members vote for Candidate A and one votes for Candidate B. Candidate A is appointed with 3 votes.
2. Example 2: With four council members holding council seats, two members vote for Candidate A and two vote for Candidate B. The mayor breaks the tie by voting for Candidate B. Candidate B is appointed with 3 votes.
3. Example 3: With four council members holding council seats, two members vote for Candidate A, one member votes for Candidate B, and one member votes for Candidate C. There is a tie between Candidates B and C for second place, so the mayor casts a vote to break the tie, voting for Candidate C. A second vote is held between Candidates A and C, with the mayor breaking a tie on the second vote if necessary.
4. Example 4: With four council members holding council seats, each council member votes for different candidates A-D. This is a four-way tie for first place, so the mayor casts a vote, voting for Candidate C. Candidate C moves into first place with two votes. This results in a three-way tie for second place between Candidates A, B, and D. Because the mayor has already voted to break a tie, but a tie still remains, then the coin toss tiebreaking provisions apply. Resolving a three-way tie with a coin toss is not easily achievable, so the three candidates should draw from a hat or follow a similar procedure

to break the tie. If Candidate D wins the draw, a second vote is held between Candidates C and D, with the mayor breaking a tie if necessary.

**V. Secret Ballots.**

Secret ballots by the Council are not permitted under the Utah Code Section 52-4-203, which requires that the written minutes and recordings of open meetings shall include “a record, by individual member, of each vote taken by the public body.”<sup>8</sup> Council votes to fill a vacancy are not exempt from this requirement. Submitting silent written votes is permitted if the voting Council member’s name is announced with the vote.
