

(Update to Business License Late Fee and Brigham City Connection Fee)



Amendment Date: January 15, 2026

1. Business License Late Fee

A late fee of \$15.00 will be applied to both Home based Businesses and Commercial businesses if their business license renewal is not completed by January 31st of each year. This fee is designed to encourage timely renewals and ensure compliance with local business regulations..

A final improvement plan or subdivision with improvements require a guaranty agreement and additional fees will be incurred. Any additional fees for inspections/engineering reviews will be the responsibility of the applicant.

*This fee is for one (1) hour of engineering review. See below for remarks regarding engineering fees.

**This fee is for two (2) hours of engineering review. See below for remarks regarding engineering fees.

The above costs are for the standard initial review of each phase of development and are required to accompany all applications when submitted. Engineering fees are calculated for 1-2 hours of review time for each phase as noted. Any additional engineering time for subsequent reviews, corrections, comments for each phase will be charged additionally at \$115.00 per hour. **The applicant will be responsible for any additional engineering fees per phase should those fees exceed the above schedule.**
